The Rotary Club of Colorado Springs received its charter on May 1, 1916. It was the very first service club in the Pikes Peak Region. At that time, there were forty four charter members of the Club consisting of the most prominent businessmen in Colorado Springs which then had less than 30,000 people. Today the Club has approximately 135 men and women members.

Throughout the years, the Rotary Club of Colorado Springs has devoted itself to community and international service. Our club members have made significant contributions to the improvement of life in the Pikes Peak region and throughout the world through the Community Service Fund (CSF), the Pikes Peak Area Rotary Endowment (PPARE) and The Rotary Foundation (TRF).

About Membership

Rotary Classification

A member's Rotary classification is a word or phrase which describes a separate and distinct business or professional service rendered to the community. As a term, it is the word or phrase which most accurately describes the principal and recognized business, or institution with which an active member is connected or that which covers the active member's principal and recognized business or professional activity.

Rotary International (R.I.) Organization www.rotary.org

The first Rotary Club was organized in Chicago, Illinois on February 12, 1905, by Paul P. Harris, a young lawyer who gathered together in a spirit of friendship and understanding a group of men, each of who was engaged in a different form of service to the public. That basis of membership, one individual from each business and profession in the community still exists in Rotary. At first the members of the new club met in rotation at various places of business of the members and this suggested the name "Rotary".

Since 1905, the ideas of Paul Harris and his friends have become ideals accepted by persons of all nationalities and of many political and religious beliefs. Today, there are 1.25 million men and women who are Rotarians in more than 34,000 Rotary Clubs in over 160 countries.

Rotary Code of Ethics (1915)

My business standards shall have in them a note of sympathy for our common humanity. My business dealing, ambitions and relations shall always cause me to take into consideration my highest duties as a member of society. In every position of business life, in every responsibility that that comes before me, my chief thought shall be to fill that responsibility and discharge that duty so that when I have ended each of them, I shall have lifted the level of human ideals and achievements a little higher than I found it. In view of this, it is my duty as a Rotarian:

- To consider my vocation worthy, and as affording me distinct opportunities to serve society.
- To improve myself, increase my efficiency and enlarge my service, and by so doing attest my faith in the fundamental principle of Rotary, that he or she profits most who serves best.
- To realize that I am a business person and ambitious to succeed, but that I am first an ethical being and wish no success that is not founded on the highest justice and morality.
- To hold that the exchange of my goods, my service and my ideas for profit, is legitimate and ethical, provided that all parties in the exchange are benefited thereby.
- To use my best endeavors to elevate the standards of vocation in which I am engaged, and so to conduct my affairs that others in my vocation may find it wise, profitable and conducive to happiness to emulate my example.
