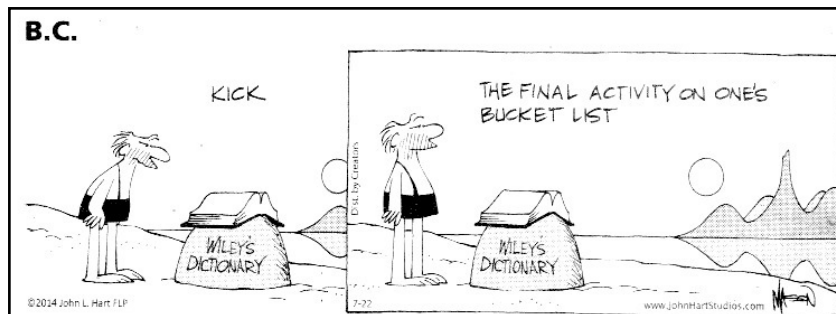
Congrats to Ned Bothfeld on his 90th birthday. What a great accomplishment.
