Eric Potter - "Fracking: The Resurgence of Oil & Gas"

Eric Potter is a geologist, and he is Program Director for Energy Research at the Bureau of Economic Geology at UT. Since 2001 he has been responsible for coordinating the fossil energy research programs at the Bureau. From 1975-2000, he was with Marathon Oil Company, engaged in oil and gas exploration across much of the U.S. He also was Associate Director of Marathon's Petroleum Technology Center in Littleton, Colorado in the early 1990s. He earned a bachelor's degree in Earth Sciences at Dartmouth College in 1972, and a master's degree in geology at Oregon State University in 1975. He is a registered professional geoscientist in the state of Texas. In his spare time, he is the chief of trail-maintenance volunteers at Great Hills Park in Northwest Austin. Today, Eric will raise our level of understanding of what is shale, what is the role of hydraulic fracturing and, overall, what does this shale oil and gas revolution mean to the good, ole USA.

#### Vocational Service Leadership Award

The RI Vocational Service Leadership Award (VSLA) recognizes Rotarians who have made a significant impact in advancing vocational service, but do not hold district or international leadership positions. This award is a wonderful opportunity for you to honor a Rotarian in your club who is actively committed to vocational service and may otherwise go unrecognized. Completed nomination forms must be submitted no later than October 1, 2013. Please note that only one Rotarian per district may receive the VLSA each year and Rotarians may only receive this award once. A detailed explanation of the award criteria is below.

Award Criteria: Candidates must have exhibited significant support of vocational service by fulfilling each of the following 3 criteria:

- 1. Exemplifying integrity and high ethical standards in their vocation and in Rotary
- 2. Using their vocational talents to serve the community
- 3. Personally undertaking at least one of the following:
- Mentoring a young person to help that person succeed in vocational pursuits
- Organizing a vocational service discussion or group workshop to inspire others to take action
- Teaching other club members about their vocation by participating in a classification talk
   Participating in a business networking event that introduces non-
- Rotarians to the principles of vocational service

#### Great things are happening...

By now, many of you have probably noticed that Rotary International has launched a new website that is very much different from its predecessor. First off, the new site does not support Microsoft Internet Explorer versions lower than 9. So, if you're still using Windows XP (like I am) and have Internet Explorer as your browser, you'll need to download another browser such as Google Chrome or Bing because Windows XP will not run any IE version higher than 8.

Once you get that all sorted out, the key to using the new site is to navigate to the bottom of the home page and click on My Rotary. The first time you go there it will ask you to log in – use the same userid and password you used before with the old Member Access. After you get to My Rotary, navigate to the bottom of that page and click on Manage. Once you get to that page, most of what you're looking for can be found at Rotary Club Central. It's a bit of an Easter egg hunt, but it's doable so hang in there.
