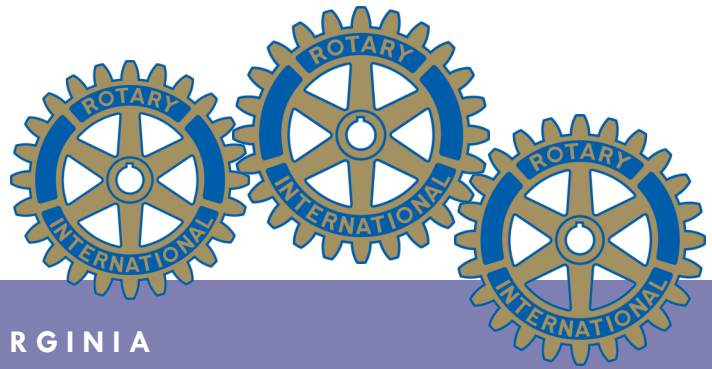

The Rotary Club of Ashburn Welcomes Tony Howard, CEO and President of Loudoun County Chamber of Commerce.

Tony Howard is the President and CEO of the Loudoun County Chamber of Commerce, a 1,200-member business organization that is Northern Virginia's largest chamber of commerce.

Howard began his tenure as the Chief Executive of Loudoun's premier business networking and advocacy organization on August 1, 2006, after seven years at the Fairfax County Chamber of Commerce, where he last served as Chief Operating Officer and as Vice President of Membership and Communications.

Before joining the Fairfax County Chamber, Howard served as the chief spokesman for Congressman Michael P. Forbes of New York, where he handled all media relations, working with major news outlets in New York City, Washington, D.C., and the East End of Long Island.

A graduate of the State University of New York, Howard is also an award-winning journalist, having worked as a reporter and editor for newspapers in New York's Hudson Valley and Long Island. Howard's journalism career earned him numerous awards for in-depth reporting, feature writing and sports coverage from his peers in the New York Press Association.

Howard currently serves on a number of non-profit and professional boards, including the Board of Directors for the Loudoun Convention and Visitors Association, the Committee For Dulles, the Loudoun Small Business Development Center, the Loudoun County VALOR Foundation and the Virginia Association of Chamber of Commerce Executives. He is also a volunteer for the March For Dimes in Loudoun County and with Cub Scout Pack 958 of Leesburg.

A resident of Leesburg, Howard and his wife Alison have one son, Jake.

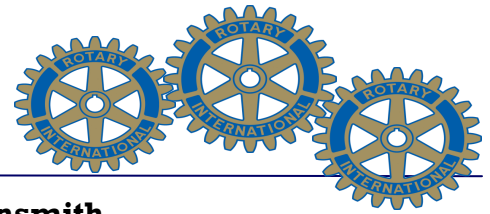

Winds of Change... A Message from RI President Ray Klinginsmith

What an amazing world! Advances in technology are happening so quickly that they cause constant changes in our businesses and professions. Yet about one-third of the world's population is still living at a subsistence level with little change in their lives. It is a stark contrast and a cause for concern.

Rotary has both a distinguished heritage and a bright future. If we succeed in helping clubs to become Bigger, Better, and Bolder in the next year, then it will be clear that the best days of Rotary are still ahead. We are fortunate to be Rotarians!
