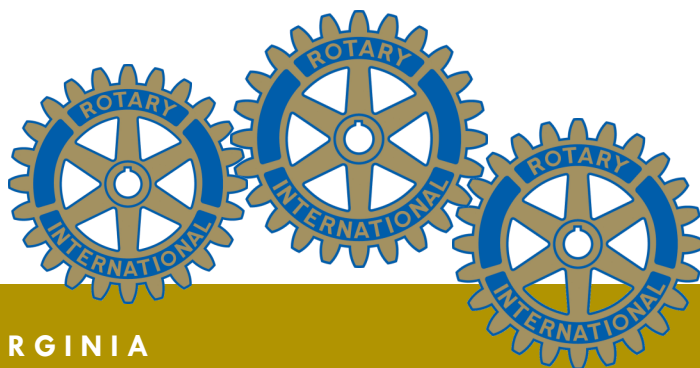

## Joanne Hart, Executive Director of Loudoun Therapeutic Riding to speak on Thursday, April 18



Loudoun Therapeutic Riding was formed in 1974 to empower and improve the lives of people with cognitive, psychological and physical disabilities through the benefits of equine assisted activities and therapies, while serving our industry through training and education.

Joanne Hart is the Executive Director for Loudoun Therapeutic Riding. She joined LTR as an instructor in 1984 after receiving her therapeutic riding instructor certification from the Cheff Center in Augusta MI. Prior to that she attended Colorado State University and earned a teaching certificate at the Meredith Manor School of Horsemanship. She is a PATH Intl. Registered Instructor and currently holds a seat on the board of directors of the Horses and Humans Research Foundation. She is a Past President of the Therapeutic Riding Association of Virginia (TRAV), and has been actively involved with PATH Intl. as past Regional Representative, and a member of the coordination committee for the annual conferences.

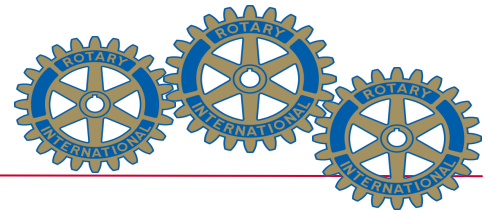
### The Four-Way Test
