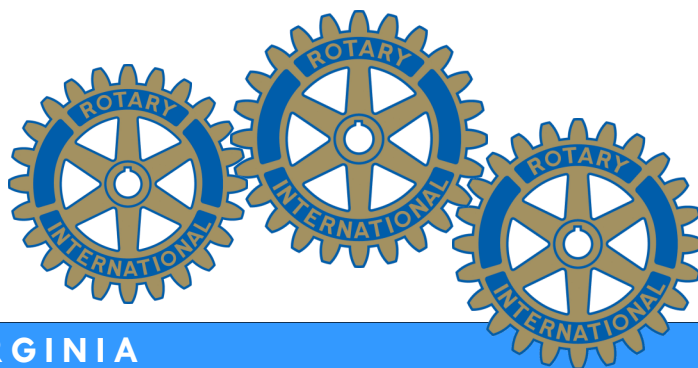

Michael L. Chapman, Loudoun County Sheriff, will be the speaker on February 27.



The Loudoun County Sheriff's Office (LCSO) is the largest full service office in the State of Virginia, handling everything from enforcement to the jails and courts. The LCSO employs around 550 sworn deputies, 150 civilian personnel and serves a population of 318,000 covering an area of 519 square miles. Chapman was elected Sheriff in November 2011.

Prior to being elected Sheriff, Chapman served as a subject matter expert (SME) and consultant for the firm of Booz Allen and Hamilton on the Global Security/Law Enforcement Team. He provided International Expertise, Management Strategy, Fusion Center Interoperability, and Training Capabilities to the U.S. Department of Justice.

Prior to his employment with Booz Allen, Chapman served the Drug Enforcement Administration (DEA) as a Special Agent for 23 years. While working with the DEA, Chapman held multiple positions in the United States and overseas.

Prior to his work with the DEA, Chapman served with the Howard County, MD Police Department in the divisions of Patrol, Investigations, and SWAT.

Chapman has a B.S. in Business Management from the University of Maryland and a Masters in Public Administration from Troy State University.

Chapman is married to the former Ann Rafferty, and they have six children.

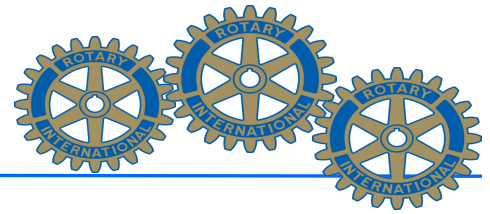
