There will be a Board of Directors Meeting immediately following the Club Meeting on Thursday, July 21.

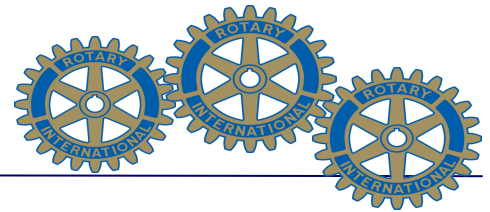

- 4) Will it be BENEFICIAL to all concerned?"



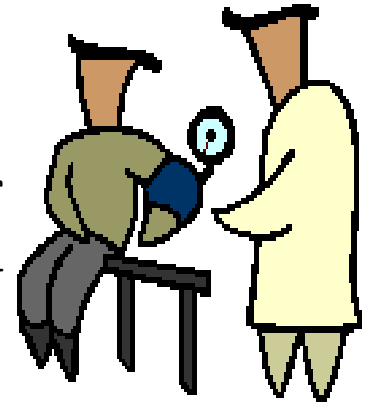
Reminders:
