

## **Rotarian Scott Mills to Speak at Ashburn**

Scott Mills' Rotarian "roots" include a Rotarian father and grandfather who were members of the Downtown Rotary Club of Tulsa, Oklahoma, the eighth largest club in the world. In 1979, Scott was a Rotary Youth Exchange Student to England.

Scott has been a Rotarian since July 1999, when he joined the Herndon Club. He was selected as that club's Rotarian of the Year for 2001-2002. Scott transferred to the McLean Club in October 2004. In 2005-2006, he was selected as the McLean Club's Rotarian of the Year. In 2006-2007, Scott was named Rotarian of the Year for District 7610. He served as Club President in 2007-2008, which was the year the McLean club was named Large Club of the Year in District 7610.

Scott is now a Charter Member of the Rotary Club of Ashburn, which was chartered on February 19, 2010, and for which Scott served as the District Governor's Special Representative responsible for the chartering of the new club.

Scott holds the classification of Employment Law, and he practices law with Enterprise Business Law Group LLC in Tysons Corner. He has maintained perfect attendance for over ten years, and he has sponsored more than 35 persons into Rotary membership.

On April 22, 2010, the Trustees of The Rotary Foundation of Rotary International selected Scott as the recipient of The Rotary Foundation's Citation for Meritorious Service.

Scott is a charter member of the District 7610 Paul Harris Society. He and his wife, Kim, who also is a Paul Harris Society member, are Rotary Foundation Major Donors, Benefactors, and members of the Bequest Society. Scott has authored several successful Rotary Foundation Matching and Simplified grants. Scott has received the Rotary Foundation District Service Award.

Scott, his wife, Kim, and children, Isaac and Casey, make their home in Fairfax County.
