
### Sunset Point Park Master Plan

- Significant open space amenity for residents and visitors
- Important area within the Town's waterfront parks system
  - Harbourview Park (ecological focus)
  - Collingwood Shipyards (urban focus)
  - Harbourlands Park (boating focus)
  - Sunset Point Park (water based, non-motorized recreation focus)







### Sunset Point Park Role

- Park has evolved over time
- Park development has been in response to community needs
- Role as water based day-use recreation area
  - windsurfing
  - day-use sailing
  - fishing
  - small craft launching
  - swimming







### Mandate for the Master Plan

- Identify opportunities to better serve the community (safety, maintenance)
- Provide a long term "vision" for redevelopment
- Identify implementation priorities
- Identify opportunities for partnerships and a strategy for community involvement
- Prepare capital cost/budget estimates







## Master Plan Design Objectives

- Upgrade the quality of landscaping (aesthetic and ecological value)
- Improve facilities (including lighting and service infrastructure)
  - picnic areas
  - swimming areas
  - parking
  - concessions
  - -washrooms
- Create focal points
- Support events/festival areas
- Improve the visibility of the park







## Master Plan Design Objectives

- Improve identification (Pretty River Parkway)
- Improve access and pedestrian safety
- Enhance parking areas (location and function)
- Improve the waterfront trail (multi-use
- Expand trail system
- Improve shoreline conditions for environmental and recreation use







## Proposed Master Plan Strategy

- Overall strategy for renewal long term vision
- Consistent, integrated use of site signage, furnishings, lighting
- Narrowing and minor "shift" in the location of the road
- Streetscape improvements to enhance "parklike" character of the roadway





## Windsurfing Beach

- Improve the shoreline conditions and access
- Enhance picnic opportunities
- Enhance the streetscape with shade tree planting
- Improve parking areas
- Improve the ecological quality of landscaping with naturalization 'pockets'







## Day-Use Boating Area

- Improve parking and launching areas
- Enhance group picnic and events opportunities
- Improve the shoreline conditions and access
- Update washrooms and concession
- Improve the ecological quality of landscaping with naturalization







## Swimming Area

- Improve access, signage and parking
- Enhance shoreline conditions to support swimming
- Improve shoreline angling opportunities
- Improve the ecological quality of landscaping with naturalization







## Enviropark

- Sports and recreation focus
- Relocate parking adjacent to facilities
- Improve park entrance and signage Create a park focal area with horticultural displays
- Improve the ecological quality of landscaping with naturalization
- Improve visibility from the Pretty River Parkway







## Sunset Point Park Rotary Partnership

- Collaboration between the Town and the Rotary Club of Collingwood and South Georgian Bay
- 100<sup>th</sup> anniversary of Rotary in 2005
- Selected Sunset Point Park as a project that would benefit the community and the Club's signature event — 'Taste of the Town'







## Sunset Point Rotary Partnership

- Outdoor tented event to showcase the cuisine in the community
- Short-term commitment to improve entry to the site, tree planting, walkways, seating and trellis
- Long-term commitment to work with the Town to carry-out additional park improvements







## Sunset Point Rotary Partnership

- Contribution of \$25K in capital works in 2005
- Landscape garden at entry
- Tree planting
- Seating area and lookout
- Pathways consistent with master plan







## Implementation Strategy

- Include park improvements during infrastructure upgrades
  - Pretty River Parkway landscaping interface
  - Signage improvements
- Ongoing Partnership with Rotary
- Expand partnerships with other community based groups
- Continue discussions with approval agencies
- Establish an annual budget for trail and landscape improvements
- Seek funding (special programs) for major improvements (e.g. shoreline, roadway)





# Long Term Recreation and Leisure Strategy

- Dialogue to integrate Town of Collingwood and The Town of the Blue Mountains delivery of leisure services
- Town of Collingwood's Recreation Master Plan needs updating
- Town of Blue Mountains propose to undertake plan
- Both municipalities will benefit from an integrated delivery of services to avoid expensive duplication

# FISHER FIELD SOCCER PARK

- 3 senior men's soccer pitches (63x100m) with lighting, irrigation and sub-drainage
- Incorporates the existing equestrian facilities
- Electrical, storm water, water supply and parking infrastructure (provisions made for 2 additional future fields)
- Infiltration wetland, and naturalization plantings (Environment Network)
- Public trails and seating areas -(develop safe pathway system for children and park users)

# FISHER FIELD SOCCER PARK

#### **COMPLETED WORKS**

- Topsoil screening and stockpiling
- Rough grading of Soccer Pitch #1 and partial grading of Soccer Pitch #2
- Sub-drains and irrigation partially complete for Soccer Pitch #1
- Storm water infrastructure complete
- Light Poles installation complete






### Soccer Pitch Lighting

Enables evening use of soccer facilities to provide longer daily use period

• Leading technology in sports field lighting with minimal light pollution (night-sky friendly)

### Water Supply for Irrigation

- Water collected and stored in sub-surface tanks
- Creative and environmentally responsible system of utilizing and recycling on-site water
- Cost effective strategy for water supply (minimizes use of municipal water)

#### WATER SOURCES

- Ground water from existing well
- High nutrient storm water run-off from soccer pitches (collected in shallow wetland)
- Municipal water as back-up
