Guest Speaker: Ed Burrows author was introduced by John Cockburn. His latest book is called "Putting Your Affairs in Order". BDO was his accounting firm. One thing that he specialized in was doing valuations for people going through a marriage breakdown.

Ed Burrows first commented about all of the great things that Rotary does in our community and then told us about the book. Some of the things that he told us were: (Not necessarily in this order)

- 1. The book is in the form of a journal and it is based on Canadian needs concerning estate planning. Space is left for the reader to insert information in the relevant sections. For example what do you need when making a PoA or what must be done by a survivor.
- 2. 50% of people are not prepared for their death. If you want specific things to happen or not happen then things have to be planned properly.
- 3. Must keep appropriate records to ensure maximum value for the estate.
- 4. Assets need to be valued properly!
- 5. Your loved ones and your executor need to be informed of what you want to happen after your death
- 6. Your executor needs to be competent to do what is required. What you want needs to be discussed with the executor

- 7. You can write your own Eulogy.
- 8. All of your contact info and all of your relatives/ beneficiaries relevant contact information needs to be available.
- 9. Joint bank accounts will be frozen by the bank until they have proper documentation. Perhaps you need a separate bank account for your spouse.
- 10. CPP, OAS, pensions, etc. need to be stopped immediately to avoid having to pay back any overpayment.
- 11. If there are two executors, then one of them should be given the authority to make a decision in the event that the two executors fail to mutually resolve any issue!
- 12. The book is available at Chapters.
