Scholarship Endowment - \$863,234

- Created in 2003
- Payout up to 5% of balance each year
- Agreement with Whatcom Community Foundation to award Scholarships through Dollars for Scholars Program- 6 years awarded total \$154,000
- Fundraising Special Project for June 30, 2012 year-\$238,634
- 100 Yr Scholarship Endowment Project for June 30, 2018, other than named fund donations-\$142,530
- Other Donations through 2018 are \$294,527
- Interest, dividends and market gains total of \$341,553
- Non-permanent endowment

Named Funds

- \$583,185

- Collection of Funds create by donors to accumulate donations and earnings that are designated for a specific purpose.
- These include Millard and Mischaikow Funds
- These also include other Named Funds created at June 30, 2018 during the 100 Year Scholarship Endowment Fundraising Project.
- Non-permanent endowment

Millard Fund

- \$218,374
- Created in 1984 to honor Phillip Millard, a Sehome High School Senior that passed away during a football game
- Awarded \$93,000 in Scholarships Outstanding Athletic award for each of the 3 main High Schools. Currently, \$2,000 per award
- Non-permanent endowment

Mischaikow Fund

- \$42,159

- Created in 1998 with member Michael Mischaikow
- Originally to fund International work
- Award of 4-\$1,500 Scholarship through Whatcom Community Foundations Dollars for Scholars program for a total of \$6,000
- Non-permanent endowment

Other Named Funds

- \$322,652
- Created in 2018 with 100 Year Scholarship Endowment Project
- Donations to these funds and their earnings are designated for a specific purpose
- Non-permanent endowment

General Endowment Fund

- \$2,225
- Donations received for other than Scholarship Endowment where donor wants to reserve donation for future projects
- Foundation is developing what future uses of this fund will be
- Non-permanent endowment

General Operating Fund

- \$7,906

- Funds used for small amount of administrative expenses
- Pay for PO Box, Secretary of State Registration, State Charities Registration
- Both DC and Susie pay postage and paper/envelope costs to send out contribution acknowledgement letters
- Occasionally also pay credit card fees associated with contributions
- Request for donation from Rotary Club of Bellingham for funds to cover the administrative expenses
- Occasionally acts as holding account until donations are allocated to specific funds, or to Rotary International Foundation
- General unrestricted funds

Undesignated

- \$8,620
- Several Rotarians made large donations to the Foundation beginning in 2007
- These Rotarians make a request to disburse a portion of these funds- Foundation considers request for approval
- Temporarily restricted funds

Special Project

- Annual Special Project that Club selects for Community
- Funds are accounted for and held by the Foundation
- Past projects raise about \$100,000 per project
- Past projects are Boulevard Park, City Swimming Pool, Whatcom Hospice House, Bellingham Technical College, Pickford Theatre, Rebound, Whatcom Rowing, Whatcom Land Trust, YWCA, Boys & Girls Club, Brigid Collins, Lighthouse Mission, Sun Community House, Lydia Place, and Scholarship Endowment Fund of the Foundation.

Desginated Club Dues

- \$48,971

- Dues collected during dues billing
- · Wacky Wickets and Vegas Nights proceeds collection
- Rotary Club of Bellingham Board makes grant requests for items such as Service Grants, and Grants to International Projects, and to Rotary International- for Polio Plus, and for Student Awards
- Generally, collection of \$33,000 or so each year
- Temporarily restricted funds
