Welcome to the Rotary Club of Welland! Rotary is a worldwide organization of business and professional leaders that provides humanitarian service, encourages high ethical standards in all vocations, and helps build goodwill and peace in the world. Approximately 1.4 million Rotarians belong to more than 31,000 Rotary clubs located in 166 countries. Rotary club membership represents a cross-section of the community's business and professional men and women. The world's Rotary clubs often meet weekly, bi-weekly or electronically and are nonpolitical, nonreligious, and open to all cultures, races, and creeds.

The main objective of Rotary is service — in the community, in the workplace, and throughout the world. Rotarians develop community service projects that address many of today's most critical issues, such as children at risk, poverty and hunger, the environment, illiteracy, and violence. They also support programs for youth, educational opportunities and international exchanges for students, teachers, and other professionals, and vocational and career development. **The Rotary motto is 'Service Above Self'.**

## Corporate Membership in Rotary

Current Rotarians, whether a member of the Welland Rotary Club or another Rotary Club, are not eligible to join as part of a corporate membership. Your corporate membership in Rotary provides one active membership. Every active member shall be an adult person of good character and good business or professional reputation meeting the qualifications of Article 6 of the "Constitution of Rotary International". Your name as a prospect for corporate membership will be considered by the Rotary Club of Welland Board of Directors. If favourable, it will be published in the Club bulletin. Once you receive notification that you have been approved for membership, you will be required to pay your annual corporate membership fees. Cheques are made payable to the Rotary Club of Welland.

In addition to traditional Rotary Club membership benefits, all corporate members have the option of having reduced associate active membership fees as well as recognition on our corporate partner's page on our website.

## Rotary Club of Welland Corporate Membership Dues
