- 2) The grants will be given to groups/organizations that will help the needy.
- 3) The grants should be given programs that are non-denominational.
- 4) The grants will be awarded to projects/programs and not for salaries/honoraria.
- 5) The grant should be applied to a wide a group as possible for more effective use.
- 6) The grants should be awarded to groups focusing on Welland and its environs (including Port Colborne) but each grant will be judged on its own merits.
- 7) The grant must only be applied to projects/programs and not to real estate.
