- Photo Cancellation Clause: To pay cancellation fee of \$70 (invoiced by photographer), for missing photography appointment or cancellation within 24 hours of scheduled time. Final photo to be chosen by photographer.
- To pay \$70 for advertiser requested photographic retakes or design changes after the final appointment.
- To pay a cancellation fee of \$150, if this contract is terminated by the advertiser after the advertiser's photo was taken.
- This contract may be terminated by Rotary at any time, and without prior notification to the advertiser, and Rotary's sole responsibility shall be to return to the advertiser any monies paid hereunder.

#### The Rotary Club of Charlottetown Royalty agrees to:

- 50,000 copies distributed to homes and every business on PEI through Canada Post.
- Choice of photography dates to be determined between advertiser and photographer.
- No money down. Advertisers are not billed until the publication is released in the spring of 2023.
- Ad cost includes photography session, design, proof, 5" x 7" matted photograph, and publication in full colour.
