Activities or hobbies that would enhance consideration as a Rotarian:

The Rotary Club of Gaylord meetings are held every Thursday at noon. Members are expected to attend no less than 60% of all weekly club meetings and participate in Rotary projects. Members are billed for dues and meals on a quarterly basis at the beginning of each quarter of a standard calendar year. In July of each year, you will also be billed for Rotary Foundation dues. Should a member choose to resign, it is the responsibility of the member to notify a member of the board of directors. The earliest date of resignation that will be accepted, for billing purposes, will be the date notification of resignation is received by a member of the board of directors. Therefore, members are responsible for all billed amounts, up to their resignation date. A member's absence does not waive a meal charge. Members are charged for all meals regardless of whether the member eats the meal or not.

Financial Obligations of Gaylord Rotary Club

The Rotary Club bills the following amounts on a quarterly basis:

- 1) Dues - \$44 / quarter. This covers national, district, and local dues.
- 2) Meals - \$12 / Thursday lunch meeting (whether attended or not).

In a typical year, there are 48 — 50 weekly meetings.

The Rotary Club bills the following amounts on an annual basis:

- 1) Contribution to Rotary International Foundation - \$100 / year. When every Rotarian donates \$100 to the Rotary Foundation, the local club becomes eligible for grants for projects. Accordingly, the Club pays the Foundation \$100 / year on behalf of all members and then bills the members for reimbursement. You will receive notification from the Foundation each year for your tax-deductible contribution.

Other Charges:

- 1) Admission Fee - \$25.
This one-time charge covers your membership plaque and pin.
- 2) Guest Meals - \$12 per guest per meal.
