PROGRAM

Bob Muh introduced Jessica Bunker,
Interim Executive Director of the Littleton
Area Chamber of Commerce, who spoke on
"Partnering for Success", looking back at
successes in 2016 as well as visions for 2017,
which include a number of partnership efforts.
Jessica holds a B.A. from UNH (2001) and an
M.S. in Resource Management and
Administration from Antioch University - New
England (2007). She served as the LACC
Downtown Director for 9 months before taking
over as Interim Executive Director.

One such partnership is the "Power of One" Collective, the brainchild of Rotarian Dave Ernsberger, which focuses on leveraging the resources of, and streamlining common objectives and functions, of five organizations: Littleton Area Chamber of Commerce, Pollyanna of Littleton, Inc.; Littleton Industrial Development Corporation; Littleton Main Street

Inc.; and the River District Commission. The Power of One Collective strategically coordinates around three main objectives: economic development initiatives, destination and relocation marketing, and grants and funding.

Jessica spoke about the chamber's approximately 20 information booth volunteers, who donated 600 hours of their time from June through October last year and assisted approximately 2,000 visitors. The chamber offers a variety of volunteer benefits, to include a volunteer dinner, and this year arranged a breakfast at the Inn at Sunset Hill and a tasting dinner at the Beal House, complete with tours, to give volunteers first-hand exposure to local businesses.

Twenty volunteers from Granite State Ambassadors (which provides training for tourism volunteers and staffs tourist information facilities at the Manchester-Boston Regional Airport and a number of tourist information centers throughout the state) toured the Littleton area to gain a better appreciation for the multitude of businesses, activities and attractions that our town has to offer.

Jessica spoke at some length about the 47th Annual Art Festival, a three-day event which drew over 40 juried artists and incorporated musical elements, demonstrations, a sock hop at the Community Center, a quilt show at the Opera House, Oktoberfest at Schillings, a penny sale at the Littleton Area Senior Center, and the perennial antique car show and parade. Preparation for the Art Festival included heavy media exposure, rack cards and public service announcements. Local businesses which were polled reported increases in sales volume ranging from 12% to 92% over comparable three-day periods. This year's Art Festival is scheduled for September 23-25, 2017.

The chamber of commerce is seeking \$15,000 this year for downtown beautification

(Article 21 on the March 14 town warrant) with the notion that a beautiful and inviting downtown area is an important driver for dramatic economic growth and development.

Under the auspices of the UNH Cooperative Extension Service, Littleton participated in a "secret shopper" exchange with the City of Rochester.

Dovetailing on a presentation given by Jon Freeman of NCIC on January 25, Jessica spoke briefly about the Southern Coos/Littleton Area Partnership and the adoption of a more regional approach to economic development. Jessica also highlighted the 6th Annual New Hampshire Restaurant Week (March 24 to March 31, 2017); a series of small business seminars sponsored by the Enterprise Center at Plymouth taking place between March 1 and May 1, 2017; and a new chamber member to member benefit, the "VIP Pass".
