Guest Speaker:

The next item on the docket was our guest speaker the highly regarded Mr. Duncan Stanners from the Honduras Economic Community Development who was so kindly introduced to us today by past-president Zuzana Carter-Edwards.

In getting into the presentation he outlined the following facts for the jury to review:

The goal of their organization is to increase access to micro-finance services.

Focus on sustainable water and health projects.

They were able to start the fundraising with \$5,000 and through additional contributions from various Rotary Clubs, Rotary International, and some government of Alberta and Canada organizations, they have raised \$600,000.


They have a variety of different courses for the citizens in their programs to access.

For the water projects, they access mountain springs, pipe the water 10-15 kms using PVC pipe to the villages, where the water is stored in large vessels and then piped to the individual homes.

They educate the community on how the system works, there are no moving pieces that need to be maintained, and everyone pays \$2 per month for maintenance costs.

They have been able to help out 2 villages so far with approximately 1000 people per village.

Next the court would like to call Mr. Bob Clark to the front to thank our speaker. Bob did a very fine job thanking Duncan for his very informative presentation and outlining where our \$10,000 donation went to last year. As a token of appreciation, the Rotary Club of Calgary Heritage Park presented Duncan with a certificate restoring the eye site of a 70 year old man.
