Our guest speaker was Laura Bechard. Laura has 30 years of family business experience as well as expertise is business processes. As a member of the Action Edge Business Coaching team she helps coach business owners in building sustainable, profitable businesses. In 2015 her family business made plans to become a licensed producer for medical cannabis. He message was entitled "Is Your Workplace going to Pot?".

Oct 17th is the dawn of a new age in human resource management - the day cannabis consumption and possession of cannabis for recreational purposes becomes legal. Laura's message was dealt with the complexities surrounding cannabis in the workplace and provided an overview of cannabis uses and highlighted key areas for employers and supervisors to review and some of the risks if your organization is not prepared, including discriminatory hiring/ dismissal practices, investigations caused by on-site incidents, poor productivity, impairment, and the costs incurred to comply with "duty to accommodate".
