

#### Speaker Recap - Friday August 4, 2017

This week, our intended speaker Karen Fry, "My Journey As a Female Firefighter" was unable to attend due to deployment to fight fires in the interior of BC. We hope to reschedule her for later in the year. Instead, Peggy Richardson gave a spontaneous new member / Classification talk.

Peggy has a long association with Rotary, and ours is the third Rotary Club to which Peggy has belonged.

She even met her husband Geoff through a mutual friend in Rotaract. Peggy grew up in Vancouver, Surrey and Langley. Geoff and Peggy's daughter Elizabeth was born in 2006 on Vancouver Island. Peggy, complete with pink hard hat, personally built their house on Gabriola Island during 2006-7. After living in the house for a few years, they rented it out and moved the family to Las Vegas for business reasons. They stayed for four years, but got homesick and returned to their own home about two years ago.

For over 20 years, Peggy worked in high tech, including a stint for the BC Ministry of Attorney General, where part of her duties included project management for numerous Y2K upgrades in various courthouses and jails around the province. Peggy now works from home, and is a professional non-fiction author and editor. She is currently writing her 35th book and has edited 366 books written by others. Most of her works resemble text books. As the author, her current books focus on aspects of technology and marketing. As the editor, she has edited works on such varied topics as chemistry, agriculture, business and Zen philosophy. She has also done podcasting with her authors.

Peggy is a director of the Gabriola Island Chamber of Commerce. She told us that, the Chamber is involved in a wide scope of activities. Consequently the Chamber (and hence Peggy) are working on a number of business community projects, including things like controlled commercial development and tourism promotion.

Peggy says she is a Rotarian partly because she works alone, and without Rotary would miss working in a team with the same vision and values. She also enjoys the Rotary fun and social life. Her personal goals within Rotary are to increase the proportion of female members and to promote partnerships with other organizations. She thinks the Chamber of Commerce would be a good partner and that we could look into forming a youth partnership with the Girl Guides, at least locally.

Peggy concluded by saying that she is looking forward to many years with the Rotary Club of Nanaimo. President Jane thanked Peggy for a delightful opportunity to get to know about her. We too are looking forward to her spending many years in the Club as a member of the Gabriola contingent.
