Today's speaker, Evan Moir was introduced by Donna



**Hais**. Evan is the President Chief Executive officer for the Nanaimo Port Authority and **Donna Hais** is a member of the Nanaimo Port Authority Board.

**Evan** has an undergraduate degree in Mechanical Engineering, is a certified accountant and has an MBA from Queens University. He has 20 years of senior corporate business

experience and is known as an analytical thinker with a strong record of implementing business strategies to develop sustainable and profitable growth. **Evan** has had a well-diversified career in Europe and British Columbia in the marine & industrial sector and has been the head

of the Nanaimo Port Authority for the last six months.

**Evan** started his presentation by stating that 93% of world goods are transported by ship and as an example said that it costs \$0.15 to ship a bottle of whiskey from Scotland but it costs \$0.25 to ship a bottle of wine from Kelowna.

The Nanaimo Port Authority was established to support trade to our area. His talk today was about the economic and social benefits to trade and ports.

There are 18 Port Authorities across Canada with most of them on the East Coast.

Canadian Port Authorities ship over 311 Million tonnes of cargo each year and have

sustained a 2.1% annual compound growth rate since 2010. This amounts to \$400 Billion worth of goods handled which equates to 213,100 full time equivalent jobs and \$14 Billion in salaries.

Ports are critical enablers of cities – Economic/cultural hubs.

In the list of the 10 most economically powerful cities in the world, 8 out of 10 are Port cities with Paris and Zurich being the only non-Port cities.

Port communities have many economic benefits. Work at Port Authorities pay higher than average wages with the average BC Port paying \$70,700/year compared to There is however negative impacts with Port cities including increased traffic problems, land use problems and environmental damage. Some examples include 50% of sulfur dioxide emissions in Hong Kong, 33% of land use in Antwerp and 85% of total truck traffic in Los Angeles.

While heavy port industry can go hand-in-hand with city environment there needs to be put in place environmental policies and incentives. Transportation policies and perhaps some port relocation to free up urban land for other uses.

It is also important that Ports start to think outside the box and look at ways to encourage other compatible businesses o Port Land in maritime clusters adding law, finance consulting and engineering companies to relocate to port land.

In 2017 the Nanaimo Port Authority shipped out 1.08 Million tonnes of logs in 42 log ships. This created 65 new jobs. Also 44,460 containers were handled at the port which is a 105% increase over 2013. From 2013-



2017, 34 cruise vessels created \$8.5million in economic benefits to the community.

Projects planned for the coming years include the Nanaimo – Vancouver passage fast ferry, short sea shipping opportunities and the Western Canada Marine



Response Corporation and upgrade to Duke Point.

Charles Ramos thanked our speaker for his very informative talk and presented **Evan** with a Rotary pen.

#### KIDS (Kids International Development Society) update

We are writing this from the town of Sauraha in southern Nepal, the lowland area near the border with India. KIDS has funded a library for one of the communities in this area. Poor eyesight is also an issue for many of the women so KIDS has also supplied 250 pairs of reading glasses that will be distributed as needed.

Sauraha is a poor rural farming area and like Cambodia a diverse skillset helps poor families survive, reduce their overhead and stretch their farming income. With this in mind KIDS is purchasing sewing machines and implementing another sewing training program for 28 women. Upon completion of their training they will be able to repair or sew new clothing for their children and families as well as make school uniforms for their children. KIDS will grant the sewing machines to the women after the program. We are sure with their resourcefulness that there will be income genera-
