**Lila Tanner** suggested that the discussions should be during Friday meetings and probably use part of the time allocated to Announcements.

Ian Williams thought it best to restrict the scope to Rotary

business (including International).

**Joan Ryan** suggested that a discussion topic should be selected a week ahead so that members have time to prepare their thoughts.

**Sean Martin** recommended that discussion should be managed by a chairperson. **Doug Cowling** suggested that it might require two persons, one to assist the chair.

**Peggy Richardson** asked about the objectives. **Charles** responded that they would be to get information and understanding of Rotary activities out to all members. Susie Stephens saw parallels with the fireside chats for new members; Charles said that they would be easier to arrange and attend, being part of a regular meeting. Susie recommended that the ideas for discussion topics should come from the members and not just the executive.

**Behzad Forghani** thought the fireside chats were valuable and appreciated the bonding that results. He hoped they will continue.

**Brent Stetar** said we should feel comfortable having discussions with visitors present.

# **Club Budget Discussion**

**President Charles** launched into this topic with



gusto, and with **Lynne Pankratz**, presented an extremely clear understanding of club finances. Note that this first part of the budget is strictly for club expenses and internal operations - nothing to do with fundraising and ways we spend our money to help the community.

Per the statements sent to each

Rotarian last week, we can see that we have more areas of spending than income - which is not unusual for this club. Our main areas of income include membership dues, Sgt. at Arms collections, and the progressive collections at meetings. Dues are the bulk of the revenue. Spending includes things like dues to Rotary International and our district, meals and the hotel, membership expenses and public relations, and conferences like PETS and District conference.

Lynne was careful to emphasize that this is a budget, not hard numbers. That means this is our best guess, and is not totally perfect. Things will change! This year, dues are a little less than we had hoped for, but still within normal ranges. The progressive donations pot (aka "card draw") is also less than expected. Some other small amounts make the numbers float a bit up and down. This is pretty close to last year's budget, and Lynne points out that looking at it in terms of the estimated and actual numbers is a better bet than making it a very aggressive budget.

In the diagrams shown, the left is income and the right side is spending. She carefully notes that we \*may\* actually have a positive budget this year, as some information and revenue is still coming through. This is partly because not everything spent, like for conferences, PETS and district. The chart does show a possible deficit, but she feels this may not actually happen.

Some things in the budget to note:

When **Bob Janes** prints the COGS, there is no cost to the club. But on weeks when he can't do that, the cost to the club is \$66 per week - WOW - we're very grateful to Bob for printing them!!!

We collected slightly more for meals than we paid to the hotel.

Half of the fellowship budget is the Christmas breakfast for kids, fireside and golf.

Installation expense this year was only programs, as we paid separately for our meals that day.

Note that the amount for insurance in our club budget is only Directors and Officers insurance, not liability insurance for the book sale, which is covered by District.

We contributed about \$800 to the five clubs' public relations items.

The secretary/treasurer category includes things like the PO box, checks, Clubrunner costs of \$584, and other bits and pieces. It's kind of our "dumping ground" for things that don't fit elsewhere. For example, Lynne had to buy checks this year, and that's not an annual expense - it only happens every few years.

Lynne did such an excellent job presenting this information, that there were NO QUESTIONS!

Next, Lynne moved on to fundraising.... Here are the highlights.

Our money comes from the book sale - almost all of it!

The \$800 noted is an annual member donation specifically to pay for the Bayview lunch.

It has been speculated that the book sale revenue may not be as high again next time due to Sears closing. This created a lot of bonus traffic for us this year. We shall have to work to keep up our marketing efforts!

The book sale made an additional \$3800 from culled book sales. These are books that are no longer good enough to sell at the regular sale, so they are pulled off the floor and sold to a broker.

The Youth budget includes Exchange expenses, and RYLA.

Community grants includes schools and Tillicum Le'lum, etc.

Community projects include the Mental Health Society, etc.

Centennial hasn't got the final numbers yet, but \$5500 has been spent on landscape architect services for the project.

Book sale grants is mostly the Literacy Society, which is \$20k, and a smaller donation to the Altrusa club.

To sum up...

The small deficit in club operations does need to be addressed, but so far we're looking good. Overall Lynne gave the impression that we have a very positive position for the club.

We have a few ways to deal with a deficit: we have a club surplus of \$20k, and it has been suggested that we use past surpluses to cover it, and see how we look next year. \$2000 is a drop in the bucket when you consider past years and our overall position. However, it was pointed out that the surplus was at least partly generated by Member donations to cover other one-time costs. This may not be expected again in the future.

It is important to note that this is still an area of discussion. There appears to be some opposition to this idea, and nothing has been decided at this time.

The board will approve the budget in due time, and more news is forthcoming.

A huge thanks for Lynne's hard work all year round, and the work of her staff, who help to keep us organized and up to date. This is a significant portion of the work for our club, and we couldn't do any of our other projects without her!
