CF-METR Maritime Testing Facility

Commander Darren Rich, the current base commander at Canadian Forces Maritime Experimental and Test Ranges (CFMETR) was our guest speaker at the Friday Nov 6th Rotary meeting and was introduced by **Mikel Knutsson**.



CFMETR is a maritime test facility located on the east side of Vancouver Island, at Nanoose Bay The Nanoose Bay torpedo testing range located in the Georgia Strait off Vancouver Island, has been operating since 1967. This base is part of Canada's National Security system. This facility is unique and is operationally controlled as a field unit where there is a joint funding agreement between the Canadian and United States Governments.

The ranges operated by CFMETR are located over an area of the Strait of Georgia known as Whiskey Golf. Whiskey Golf is a testing range that is the most important of the four test ranges maintained and operated by the Naval Undersea Warfare Center Division, jointly operated by the United States and Canada. Over 56 square nautical miles are moni-



tored. Whiskey Golf occupies the Ballenas Basin which is the deepest part of the Strait of Georgia. It is several hundred metres deep, several dozen kilo-

metres long and several kilometres wide over a seabed composed of soft mud and free of underwater obstacles.

The facility has a 3-dimensional sonar tracking system for monitoring the performance and position of objects. Equipment tested at the facility consists of a variety of devices, including sonobuoys, sonar systems (ship and aircraft), torpedoes and the repair and overhaul of the dipping sonar used on Canada's Sea King helicopter fleet. The range tests between 300 to 400 torpedoes annually, most of them American.

The range employs 68 people, including 11 Canadian military naval officers and six U.S. civilian technicians. The U.S. has invested \$170million in the facility. Canada's investment is \$47-million. Commander Rich informed us that the benefit to the



mid-island economy is approximately 9.5 million dollars per annum. This includes salaries, goods and services, contracts and property taxes.

Due to the large number of submarine cables terminating at Winchelsea Island, a no prawn or crab fishing (no bottom contact) and no anchoring zone exists within this area.

There has been some controversy about ownership and rights in the area. The Canadian government owns the land used for the range. The foreshore is owned by B.C. and used by the federal government under a sixty-year agreement signed in 1988. The Nanoose Bay seabed was also owned by British Columbia and leased to Ottawa for a \$1 per year.

Recently CFMETR - Nanoose Base had an open house celebrating 50 years in Nanoose Bay. The base has an open house every two years for the public to visit and view the operations.



Our speaker was thanked for his presentation and his service by **Bruce Samson**, who presented **Commander Rich** with the coveted Rotary Pen made by **Dave Connolly**.

IN MEMORIAM Rotarian John Morris



April 10,1920 — November 7th, 2015



Just a few days short of his 55th anniversary with our Rotary club and perfect attendance for that time, John Morris passed away peacefully at Nanaimo Hospital.

Joined Rotary in 1960 with the classification of Public Highways, serving as President in 1969-70. He chaired the Program Committee for many years, and until recently, always performed the *Address to the Haggis* on Robbie Burns day dressed in his kilt.

John was born in Scotland, just outside of Perth and at the age of 12 years fell in love with flying while visit-

ing a local fair. He got his flying license with the RAF in time to join the No. 19 squadron led by the famous leg-less ace, Douglas Bader, flying the Hawker Hurricane fighter. John also flew the Spitfire, but said he preferred the Hurricane.

During the war John served in several campaigns and survived five crashes, the last of which left him with severe burns and ended his flying career.

It was on a tour of Canada after the war that John met his future bride, Louise, and after they married the couple lived in the UK for a year, but settled back in Louise's native Canada. The couple had no children.

The Morris' settled in Prince George where John worked with Department of Highways and was involved with road building in the central and northern part of the province. When an opening came up for a posting on Vancouver Island, Louise encouraged John to take it where she could be closer to her family. John worked for Public Works in Nanaimo until his retirement.

As well as being a dedicated Rotarian, John Morris was also a member of Ashlar Masonic Lodge and a generous supporter of many charities in Nanaimo.
