Funding preference will be given to those organizations/projects that help to alleviate poverty, improve literacy and health, and promote service. Funds cannot be used to cover administrative costs.

The grants that we award generally range from \$250 to \$1000. This of course is a guideline only. Requests are reviewed on a quarterly beginning in July. The club has the ability to determine what the actual approved amount will be based on available funds and other priorities.
