1. To determine your group's eligibility for support, please refer to the Swan City Rotary Club of Grande Prairie ("SCRC") website for criteria and guidelines; in addition, please provide the following information. 2. The Allocation Committee will meet quarterly and will review proposals and determine SCRC abilities to financially support. ***Note that the process may take up to four months based on AGLC processing.***
3. SCRC requests that the benefactors provide a final report providing information regarding the impact SCRC financial support had on the project. Report will be due one year after receiving the funds. We also love photos of the community projects. Please share those with us.
4. The SCRC may request that your organization support our two Lotteries: *Cars for Christmas* and *Cash and Camping*. These lotteries provide SCRC the ability to financially support local non-profits and charities. Your organization will be asked to support our Lotteries by:
 - a. posting on your organization's Facebook/Social media page and encouraging membership to share the lottery posts;
 - b. providing a written testimonial to SCRC on how the funds will benefit your organization; and
 - c. if requested by SCRC, provide interviews to local media outlets.
5. In order to maximize funding opportunities, SCRC may share your application with other Rotary Clubs including, but not limited to: Rotary Club of Grande Prairie, Rotary Club of Grande Prairie Sunrise, and Rotary Club of Grande Prairie After Five.
