REVIEW



This week was a celebration of President Jim and the exceptional Rotary year under his guidance and leadership. The fun began as soon as we arrived with a receiving line made up of past presidents dressed up in honor of the things Jim loves – tennis, UW, and skiing. It was an impressive sight!

Past President Erin Black presided over the meeting that included the introduction of Kaitlin Bealer as our 20th new member for Jim's year. Kaitlin was born and raised in Yakima after her parents

moved from Illinois shortly before her birth. The mom to two children, she balances her family life with her passion for the manufacturing industry. She recently completed a degree in Supply Chain and Operations Management with plans to continue her masters. As the Customer Service Manager at Kwik Lok, she is committed to empowering others and does so as a volunteer with the Women in Manufacturing Washington where she serves as Vice Chair of the Chapter Board. She also recently joined the Board of Junior Achievement. Outside of work, she enjoys photography as a creative outlet. It was the perfect way to celebrate the work of the Membership Development Committee.

Past President Charlie Eglin continued with a prayer of thankfulness for Jim's leadership, his service to our club and community, Jim's dad and grandfather for instilling the importance of Rotary service, and the work of Rotary to make life better for those less fortunate. With President Jim called to the stage to sit where we could watch him, Past President Erin shared her love of reading with her new favorite two-chapter book, *The Legend of JDawg*.

It was the story of a legend who goes by Jim, Jimmy, JDawg, or James, and took over the reigns as the 106 President of Yakima Rotary in July 2024. From the beginning Jim made it clear that it would be anything but ordinary. The meetings started with music playing overheard and ended with *This Day in Music History* and *This Day in Automotive History*. There were stories told about tennis, tennis and more tennis. It was a year full of fun and purpose. Chapter one talked about walking in the Sunfair Parade; a backpack project to provide school supplies for every student at Hoover Elementary; the most successful Rotary auction in history that

raised over \$400,000 for Rotary Charities; and outstanding programs that included Adam Beach, Shaquem Griffin, Cheech Marin, Robert Dugoni, and General Jim Mattis. Chapter two highlighted a different side of Jim as a thrill-seeker, accident prone, with driving skills that have earned him his own fan club.

His brother Todd surprised him with his own presentation. He talked about how he and Jim grew up with Rotary, the pride that their grandfather and father would have had to see Jim as president of Yakima Rotary, and more about Jim's driving abilities that included a speeding ticket in Oregon that miraculously ended up being dismissed. There was music with Past President Doug Rich who created an original song to the melody of Wake Me Up Before You Go-Go; the perfect sergeant-at-arms by Past President Kellie Connaughton with questions about music, cars, and tennis; and talk about his love for his wife Dawn and their girls.

Every week Jim encouraged us to show up with open minds and hearts, to leave the noise of the world outside, and step into Rotary with curiosity, kindness, and a willingness to laugh. For that, we will always be grateful. The day ended with call for a motion and a second from the Past Presidents' Council (that include a brief scare of cricket sounds) to join their esteemed group with a yes; a thank you to Jim for his leadership, legacy, and ability to turn every meeting into a cross between a TED talk and stand-up routine; confirmation that Jim is 107 and not 106; and time for Jim to share a thank you to his family and each one of us. It was a remarkable year!
