REVIEW

Last week's meeting featured two of our own members speaking about strategies for effective charitable giving, a timely topic with our upcoming auction on Saturday. Quinn Dalan introduced Dan Sullivan, of The Sullivan Group at Baird Private Wealth Management, and Molly Neal, Assistant Vice President and Trust Advisor at Baker Boyer Bank. Starting with the work of Yakima Rotary Charities they shared that the annual spending for Rotary Charities is roughly \$250,000 spread over our academic and vocational scholarships, club projects, Operation Harvest, community and committee grants through Allocation & Review, the annual Presidents Fund, and literacy. Money is raised to support our work through the annual scholarship dinners, donations for Operation Harvest, weekly fines, and our bi-annual auction. The auction supports our giving over a two-year period – its success is crucial. Only a small portion (6-7%) is used for administration costs. All the money raised during the auction goes directly to Charities, with none going to running the club. There are many ways to give. In a very simplified approach, here are a few notes.

A charitable contribution is a transfer of property to a charity. It can be cash, real estate, personal property, stocks/bonds, mutual funds, or any other asset. Once gifted, you are eligible for a tax deduction. It does require that the donor itemize when submitting their tax return. Deductions are subject to AGI limitations and may be limited by the type of property gifted and the type of charity that receives it.

Highly appreciated assets are assets that you own where the fair market value is significantly higher than what you paid for it. You don't pay capital gains until you decide to sell it. When you donate an appreciated asset to a charity, the donor receives an itemized deduction for the fair market value of the asset and the charity avoids capital gains tax on the disposition of the asset.

Traditional IRAs are another way to make a charitable contribution. One tool available to people over 70 ½ years old is through Qualified Charitable Distributions (QCDs). Transfers can be made directly from your IRA to a charity. When doing so, the transfer is not considered an income distribution by the donor and is not reported as such. A donor advised fund is a tool becoming more common. Sponsored and maintained by organizations such as charities, community foundations, and financial firms, in essence it's an

account that is established that qualifies as a public charity. Property/assets transferred into the account qualify as a charitable contribution and the donor receives a current income tax deduction. The donor can decide how it is invested and distributed. Record keeping is simplified, and other family members can be brought into the decision-making process. Testamentary gifts come from your will or estate and are another way to give.

It's important that we don't lose sight of why people give: for their communities and their fellow citizens. With the auction coming, how can you utilize these tools at the auction? You can pay for your Raise the Paddle or large auction item with QCDs or donate highly appreciated securities rather than cash. Each person should consult their financial advisors and accountants to determine the best way for you to make your charitable contributions.

What else happened on that beautiful fall day? We were greeted by Rob McCormick and Sharon Miracle; a moment of inspiration by John Cooper reminded us that as the days get shorter and fall makes way for winter, to take time to practice gratitude and connect with each other; and Kellie Connaughton did a great job with sergeant-at-arms. After welcoming guests, President Jim shared member recognition and appreciation for Rotarians Amy Maib and Soneya Lund who helped a person in crisis with their dog. Soneya temporarily fostered the dog and Amy paid for the dog to be spayed and arranged for a permanent adoption. Please keep Greg Luring in your thoughts as he recovers from a fall. You are welcome to visit him at Landmark as he rehabs. One more congratulation was given to Kyle Curtis and LaDon Linde on their reelection. Rick Fairbrook announced that Rotary Bell Ringing will take place the week of December 9th through 14th. All the funds raised stay local to eliminate student food insecurities, move families out of generational poverty, stock their food bank, and provide food for 16 school pantries monthly.
