Becoming a Corporate Member

1. **Approval** – Applications are reviewed and voted upon by the Rotary Club of Pullman Board of Directors.
2. **Appointed Members** – Appoint one executive member to serve as official club member and primary contact and up to two additional members. All members shall receive a Rotary pin and are encouraged to attend club meetings, and District and International functions.
3. **Executive Member Role** – Primary member upon which attendance is counted, can hold office, may serve as a board member and may vote on all club matters.
4. **Additional Members** – Can vote on behalf of the primary member, and their attendance will count in the absence of the primary member.
5. **Changing Members** – The Club Board of Directors will review and approve requests to change corporate members.
6. **Induction** – The executive member will be formally inducted into the club as established by the club.
7. **Classification** – The classification of the eligible corporation will be established by the club.
8. **Rotarian or Regional Rotary Magazine** – The executive member will be the recipient of the Rotarian and any Regional Rotary magazine.
9. **Rotary Dues** – The corporation shall be responsible for all dues.

Corporate Member Dues

Corporate membership dues are \$235/quarter or \$940/year. Your executive member will receive a quarterly invoice via email. This includes 1 paid lunch at each weekly meeting. Additional lunch guests are \$12/person and can be paid directly to the Treasurer.

Corporate Membership Application
