Nora Ryan, Director of Michigan Legal Help and Sandra Ambrozy, a volunteer for the organization.

Michigan Legal Help is a website that offers tools and information to help people understand and manage their civil legal problems. There is a huge need for this as 42% of divorces, 2% of debtors in collection cases, and 5% of tenants in eviction cases are represented by an attorney.

The organization provides legal information, not legal advice, offering suggestions and access to resources. Through the website, civil legal help is easy to understand and accessible. It offers do-ityourself forms, "know your rights" articles, resources and forms, a guide to local legal help for individuals, a live chat service, and 62 self-help centers around the State. Ms. Ambroz volunteers one day a week at one of the centers in the Coleman A. Young Municipal Center, helping 50-75 manage their court cases each day.
