## TODAY'S PROGRAM

Heidi Pfannes, Vice President of Business Development, Albert Kahn Associates, Inc., talking about

the Albert Kahn Legacy Foundation.

Albert Kahn was born in Germany in 1863 and came to America at age 12. He worked as an office boy for the Detroit Architecture firm, Mason & Rice, and by age 22, was Head Designer. His architectural education came solely through a scholarship to travel Europe.

Albert Kahn's firm tackled all types of projects, but the most important contributions were its innovative industrial structures. Incorporating reinforced concrete into their buildings allowed the structures to be designed with vast areas of glass that brought in more natural light and better ventilation. This dramatically improved the working conditions for employees in an era when manufacturing buildings were considered dark and dangerous spaces.

The Foundation was established in 2020 to celebrate and preserve the history, work, and impact of Albert Kahn through exhibits, lectures and educational programs, building, bike and walking tours, reference and research services and an educational website.
