## Process

- 1. <u>Approval</u> A corporate entity or organization can become an eligible corporate member of the Wayne Rotary Club through the approval process established by the Club.
- 2. <u>Designees</u> Upon approval, the corporate member may appoint up to four persons to be its designee, one of whom must be a member of the corporation's executive group (the prime designee); others can be managerial or key individuals of the entity.
- 3. The prime designee shall be listed on the rolls of Rotary International as the official member of the Club; shall have the ability to hold office, be a board member, and vote on all club matters. The additional designees may be assigned (by the prime designee) the ability to vote on club matters, and their attendance will count toward the attendance of the prime designee if the prime designee is absent.
- 4. Each designee shall receive a Rotary pin and are encouraged to attend the club meetings and functions as well as District and International functions.
- 5. <u>Changing Designee</u> -- The Club will determine the ability of the eligible corporation to change any of its designees providing that one designee is a member of the eligible senior executive group.
- 6. <u>Induction</u> A corporate member designee will be formally inducted into the club as established by the club.
- 7. <u>Classification</u> The classification of the eligible corporation will be established by the club.
- 8. <u>Rotarian or Regional Rotary Magazine</u> The prime designee will be the recipient of the Rotarian and any Regional Rotary magazine.
- 9. <u>Rotary Dues</u> The corporation shall be responsible for all dues. Corporate dues are \$300/year and payable by July 1 each year.
