## LACEY ROTARY SCHOLARSHIP AWARD PROCEDURES

1. Student and parents notified of scholarship award and invited to Lacey Rotary Thursday lunch meeting at St. Martin's Worthington Center for introduction and presentation.
2. Student/winner will inform the registrar/admissions office of the scholarship at the college he/she will be attending.
- 3. Student/winner is responsible for the college registrar/admissions office sending written confirmation(from that office) of enrollment to the Lacey Rotary Scholarship Committee Chairperson. Funds will not be released until this is completed.**
- 4. Scholarship funds will be sent directly to the college naming that college and the Student jointly.**
5. Student/winners are required to revisit Lacey Rotary within a year of the scholarship for an update of your activities.
6. For four(4) year renewable scholarship recipients: "The Lacey Rotary Foundation's intent is that scholarship recipients must be full time students, as defined by their institutions of higher education, beginning no later than September of the year following receipt of the scholarship. Foundation funds must be used no later than the fifth anniversary of the scholarship award."
7. For one(1) year scholarship recipients, Foundation funds must be used not later than the second anniversary of the scholarship award.
