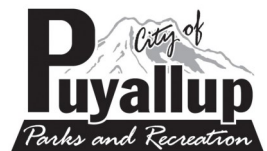
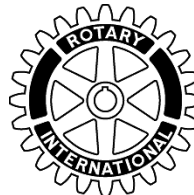

Agreement

In order to guarantee all benefits associated with printed materials, your sponsorship commitment must be made by July 1, 2017. Payment must accompany your signed application. The sponsor shall be entitled to receive all the benefits provided in the attached materials for the sponsorship level chosen upon receipt of payment in full. Sponsor agrees to pay the amount due in full. The Puyallup South Hill Rotary Club in conjunction with the City of Puyallup Parks & Recreation shall be entitled to recover any fees and costs from sponsor in the event collection activity is required following non-payment. There are no refunds in the event that Hounds on the Hill is canceled.

Liability & Indemnification

Vendor shall indemnify and hold harmless the Puyallup South Hill Rotary Club and its members and the City of Puyallup and its employees from and against all claims, liability, loss and expenses including reasonable costs, collection expenses and attorney's fees incurred, from any claim, suit or proceeding arising out of the use of the facility by the Vendor. This clause shall survive the termination of this Agreement. The Puyallup South Hill Rotary Club and the City of Puyallup assume no responsibility to the Vendor for consequences of any act or omission of any third party. The Vendor is responsible for damages incurred by third parties (including employees of the Vendor) during their possession of the premises. The Puyallup South Hill Rotary Club and the City of Puyallup assume no liability for damage or loss of personal property or equipment left in any rental space during or after the event. The Vendor assumes full responsibility for the conduct of its employees or third parties hired to provide services for the Vendor.

The Vendor agrees to exercise the utmost care in the use of the premises and property and shall indemnify and hold the Puyallup South Hill Rotary Club and its members and the City of Puyallup and its employees harmless from and shall process and defend at its own expense any and all claims, demands, suits at law or equity, actions, penalties, losses, damages or costs of whatsoever kind of nature, brought against the Puyallup South Hill Rotary Club and the City of Puyallup arising out of, in connection with, or incident to the use of said premises or property and/or the vendors performance of failure to perform any aspect of this agreement.

As a condition of rental, the Puyallup South Hill Rotary Club or the City of Puyallup may require proof of insurance from the Vendor. If insurance is required, the policy must include bodily injury coverage of at least \$150,000 per occurrence, aggregate of at least \$1,000,000 for the event. The Puyallup South Hill Rotary and the City of Puyallup shall be specifically named on the policy as being insured. The policy shall cover personal injury from all causes.
