Program: The Organization of Rotary

Our scheduled speaker's presentation (Ruth Lee of the Pathfinders Youth Society) was postponed until May 13, 2025.

Laurie therefore took a few minutes to review with us (and our guests) how Rotary International is now organized throughout the world.

February 23, 2025 was Rotary's 120th birthday. On that date Paul Harris convened the first Rotary meeting in Chicago, Illinois, to unite professionals with diverse backgrounds to exchange ideas and form meaningful, lifelong friendships. Today the Rotary organization includes members dedicated to humanitarian service in over 45,000 clubs and over 200 countries and geographical areas around the world.

Rotary as a Pyramid Structure

Think of Rotary as a pyramid with several levels that get smaller as they raise to the top. The levels or layers of Rotary International are:

- 1. The individual members
- 2. Clubs
- 3. Districts
- 4. Zones
- 5. The apex is Rotary International

Members

There are over 1.4 million individual Rotary members in the world, and in addition there are all the individual volunteers who help us. Think of the volunteers we had helping us with the starfish program.

Clubs

Our individual members are formed into clubs, and there are over 36,000 clubs in over 200 countries and geographic areas around the world. Our individual members and clubs are the most important part of the pyramid because they are the foundation which hold up the structure, and do the main work on the ground that directly impacts people's lives. There are 27,000 Canadians belonging to 728 Rotary Clubs in Canada

Districts

Each club belongs to a District, of which there are roughly 535 Districts in the Rotary World. Our Rotary District 5050 currently has 58 clubs, and is an international District which covers the geographical area that extends from Everett, Washington to Hope, British Columbia. Of course, each District is headed by a District Governor who is currently Dave Duskin from Arlington, Washington. Our District Governor for 2025 – 2026 is Isabelle Hayer of the Rotary club of Surrey.

Zones

Districts are divided into Zones. Our District 5050 is part of Zone 28, which extends west to east, from coast to coast. The majority of Districts in Zone 28 have both Canadian and American clubs. Zones usually are made up of about 18 Districts, and there are 34 zones in all. Since 34 Zones is still a large number, the Zones are partnered in pairs for purposes of electing the Directors of Rotary International. Our Zone 28 is partnered with Zone 32 which covers the eastern seaboard and includes Boston and New York.

Rotary International

Rotary International has a Board of Directors and, of course, a President. The current president of Rotary International is Stephanie Urchick, from Pennsylvania. Before Stephanie, the President was Gordon McInally, and before him it was Jennifer Jones from Ontario. The President in Alex's year of 2025 – 2026 will be Mario Cezar Martins de Camargo (affectionately known as "Super Mario"), from Brazil. The paired Zones elect the Directors of RI, with the selection alternating between the two Zones. The Directors serve two-year terms, and the President of Rotary

International serves a one-year term. The Board of Rotary International is made up of the President and the 17 Directors elected from around the world.

Rotary International has its charitable arm, called the Rotary Foundation, which is run by the Trustees who are all Rotary members. The Rotary Foundation (Canada) ("TRFC") is a Canadian registered charity, federally incorporated on December 22, 1967. TRFC has an all-Canadian Board of Directors, which meets regularly and makes all decisions in connection with the management and investment of annual fund donations by Canadians. Among the 27,000 Canadians belonging to 728 Rotary Clubs in Canada, TRFC is a means of donating to projects including the eradication of polio, which Rotary has been a trailblazer for over 40 years — working with and supporting our partners in the Global Polio Eradication Initiative.

We focus on projects that promote peace, fight disease, provide clean water, sanitation & hygiene, help mothers and children, support education and grow local economies, as well as on Canadian and international disaster and humanitarian relief. Rotary has in the recent past hosted its annual international conventions attended by 30,000 to 35,000 Rotarians from Canada and around the world in Montreal (2010) and Toronto (2018), and will host it in Calgary (June, 2025).


Lynda- pleased that Wine Fest tickets are selling.
