CRCID, as a Rotary organization, has developed a new CRCID strategic plan to meet the goals and objectives of Rotary International's strategic plan. It has also been developed to ensure CRCID continues to receive Canadian Government funding that has greatly assisted Canadian Rotary clubs implement their poverty reduction vision since 1985.

The strategic plan provides a framework for poverty reduction in the developing world that matches what Rotarians are already doing in many communities in these countries. What is now being recommended is that these many community projects be linked to the goals and objectives outlined by the governments and other national organizations within the specific developing countries under a unified CRCID program in Healthcare Concerns; Literacy and Education; and, Water Management.

In order to make the transition to this program-based approach to development CRCID will not be accepting any new project applications during the 2004/05 Rotary year. This was a very difficult decision to make but was prompted by the necessity of ensuring that as many of the currently approved projects be funded under the current contribution agreement. CIDA has graciously extended the current agreement for one year to enable CRCID to wind down its current project-based program and make the transition.

The reason behind this dramatic change is due to an evaluation by the United Nations and the OECD (Organization for Economic Cooperation and Development) countries on the impact of international development on poverty reduction in the developing countries. It concluded that small independent projects were not making a significant impact upon poverty while requiring an inordinate amount of the developing countries human resources. It was felt that a program-based approach would have a greater impact upon poverty reduction and be more efficiently implemented.

Canada, as a member of OECD, has endorsed this new program-based approach to international development and CIDA, Canada's international development agency, is recommending that each of its partner NGOs (non-governmental organizations) also adopt this new approach. CRCID was informed of CIDA's new mandate in September 2003.

In response, CRCID consulted with CIDA for clarification and formed an ad hoc Strategic Planning Steering Committee to draft a new strategic plan to be ratified by the Board and then the members.

It is anticipated that under this new mandate, CRCID will continue to fund projects but they will be coordinated under an overarching program within one of the priority countries. These priority countries are Bangladesh, Bolivia, Ethiopia, Ghana, Honduras, Mali, Mozambique, Senegal, and Tanzania.
