Lynda Lawrence gave a couple of happy bucks, firstly, that Marco was doing a little better (Best wishes from all of us go out to Marco and Lila), and secondly, for the support of Adrienne, Patrick and Ineke (and let us not forget Lynda herself) for attending on Saturday at Marks Work Warehouse to sell hotdogs, where they raised \$675 for the food bank. A special thanks goes to Brian Bekar for supplying all the food and equipment for this event.

David Rempel gave a happy dollar as he was honoured to have been presented last week with the Queens commemorative medal for his work with the adoption Society (which has, I believe, been responsible for the adoption of approximately 200 kids from Russia, including Dave's own daughter, into homes here in Canada).

Bob Shantz advised that Irena's father passed away, and has gone to "a better place".

Sharon Kyle recently saw former club member Dot Ralston, and passed on her best wishes.

The first order of business was a discussion of the proposed new bylaws and constitution of the Club. One proposal was whether we should allow corporate membership. Terry Becker advised that another Club in our

It was decided to refer the matter back to the Bylaw Committee for further study and recommendations before the Club votes on adopting the new bylaws. Eric urged the Club members not to put off reading the proposed Bylaws, so we can have a proper discussion and then get on with the job of implementing them.

Eric Mollema reported that we have 27 Active members, 1 Leave of Absence, 7 active "old f- -ts" i.e., R-85's, and 1 Honorary. He urged us all to bring a potential member to the Club meetings so we can increase our membership.
