

Ineke Boekhorst advised that she and Peter had the privilege of attending a Rotary meeting in Kelowna (her daughter is a member and past president of that Club) where she met the speaker who was Ramesh Ferris (a polio survivor and the subject of the video film which was presented at our last Club meeting). Ineke said he was a very inspiring speaker. She had a book by Ramesh autographed by him which she auctioned off at our meeting for \$25 to raise money for the Rotary Polio fund. Guest Speaker

Betty Johansen, one of our newest members, gave her "Who's Who", so we all got to know Betty a little better as she gave us a brief accounting of her life. Betty is a Certified General Accountant and a partner at the Maple Ridge firm of EPR (Evancic Perrault Robertson) where she works with Patrick Smith and Kathi Halpin.

Right off the bat, Betty showed her ingenuity and ability to multitask. She brought two rather large accounting books with her to the meeting which she placed on the floor and stood on

while giving her talk (thereby not only raising herself at least 4 inches off the ground so everyone could see her better, but also demonstrating that although she is a very busy accountant, she was certainly on top of her work).

Betty was born in North Vancouver, and moved to Victoria when she was eight years old. She showed an early inclination to public service by



becoming involved with the Kiwanis Club in that city.

As a teenager, she had various jobs including working at Robson Park where she served a few months of hard labour, including digging some ditches.

At the age of 20 she got married, and attended the University of Victoria. During the summer, she worked for the Provincial Government in testing water conditions relating to fish habitat below the waterfalls at the foot of various dams. Betty advised that apparently the water at the foot of these waterfalls gets so much air in it as a result of the turbulence that it can be damaging to the fish, causing them to suffer a condition similar to the bends suffered by scuba divers who come up to the surface to quickly. (Now that gives a new meaning to "a bend in the river"!).

Betty and her first husband moved to Maple Ridge where their son was born. When he (her son) was a year and a half old, she started a CGA program by correspondence which enabled her to embark upon her career while staying at home to look after her child. When her son was eight years old, he became seriously ill as a result of contracting an unusual virus which caused his kidneys to shut down. During the same period, both of her parents died and she and her first husband separated, but somehow she managed to get through this very difficult time in her life.

Betty remarried (and no doubt, with her teenage job as a ditch digger emblazoned on her brain, decided this was one way of quickly gaining two more (step) children while avoiding 18 months of hard labour). She and her second husband now even sport some grandchildren.

Betty's first accounting job was at a Jewish synagogue. (There must be joke here. "Two accountants walked into a synagogue" ?). She joined EPR in 1990, became a partner in that firm in 2001, and, as they say, the rest is history.
