

Ineke Boekhorst (who for years has worked on the Caribbean Festival with **Deddy Geese**, **Debi Pearce** and others, and was herself one of the prime movers behind the success of the Fest in past years) also noted and thanked Dave for his commitment to the event.

Guest Speaker - Betty Johansen

- Powers of Attorney - from an Accountant's Perspective

On very short notice, Betty gave us a view of Powers of Attorney from the Accountant's standpoint. In her experience failure to have a power of attorney not only makes things harder for the individual and members of his family, but also can increase costs and be somewhat of a headache for accountants who are called upon to give professional assistance to someone who is incapacitated.

Tax returns are supposed to be signed by the taxpayer or his or her legally authorized agent. If the



taxpayer is incapacitated, this can present problems where no one has been appointed by power of attorney to take care of the taxpayer's financial and business affairs.

Even when a taxpayer is not incapacitated, they may be away on holidays or out of the country for some reason when a tax return or other important document needs to be signed in a timely way. (Generally speaking, powers of attorney may be exercised while the maker still has capacity, and continues or "endures" in the event of a subsequent incapacity.) Having a properly drawn power of attorney can save you a lot of headaches, time and money in these circumstances.

Betty's experience (both professionally, as well as personally with family members) is that if a person does not have a power of attorney and the Public Guardian and Trustee becomes the person's "Committee" and takes over the person's financial affairs, things may become very expensive and grow to a grinding halt for a period of time (or at least encounter a number of speed bumps along the way). Family members have to get the consent of the Public Guardian and Trustee to do things such as selling jointly owned property which the family knows is in the best interest of their loved ones, and this can be a frustrating exercise.

Betty also exhorts everyone, including young people with little or no assets, to have a will. If there is no will and therefore no executor, there is no person who can legally sign tax returns for a deceased person until the court appoints an "administrator" to be in charge of the deceased person's estate. (Other jobs, such as instructing the funeral home regarding burial arrangements, also require a legally authorized representative to give authoritative instruction.)

When making gifts in a will to charities, a will maker should obtain the advice of an accountant as to the best way to structure the gift, to make sure it not only saves taxes but also is capable of easy tax calculation.

Betty's view is that a person should review their will at least every five years, as things rapidly change in a person's life, and the cost of doing so is well worth it in the long (and sometimes even the short) run.

[And here is a useful tax tip from our Speaker: if you are planning to die on a December 31, try to hold out until the first day of the new year, particularly if you have a capital gain that is subject to taxation.]
