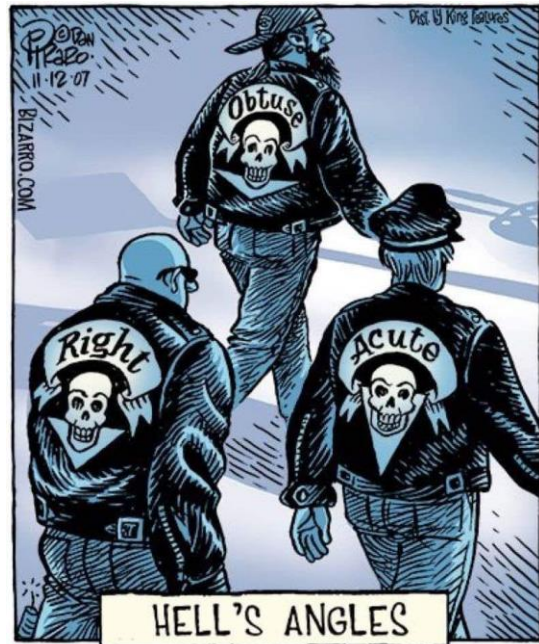

We then dug into an excellent buffet meal prepared by the chef at the Sunset Ranch Golf and Country.

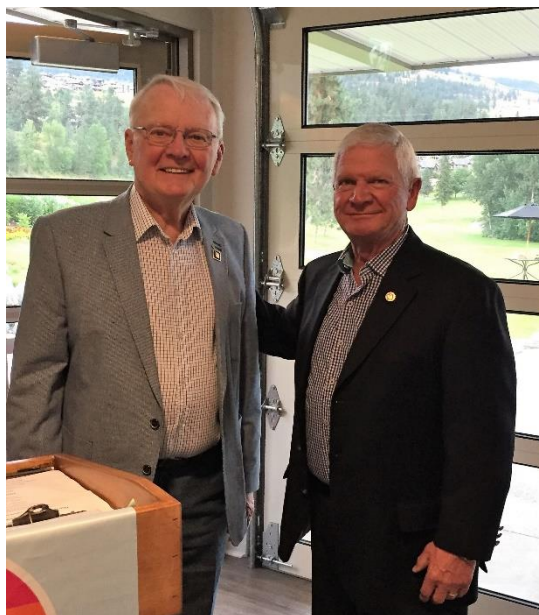

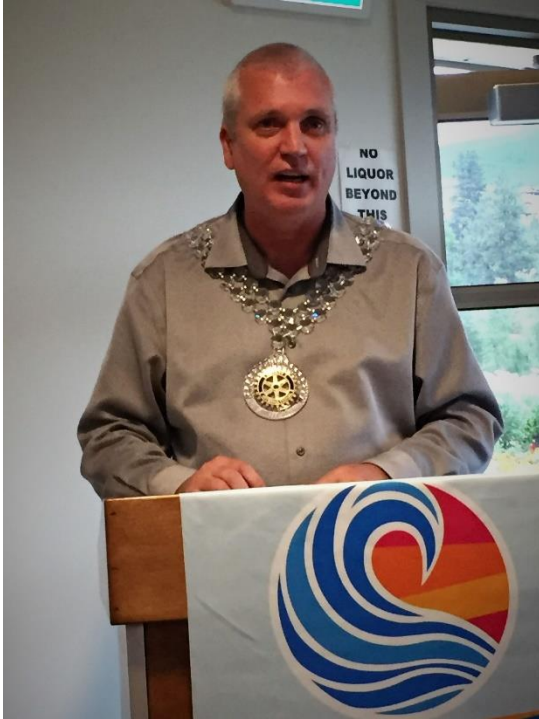
