# HEALTH CARE John Carpay, Alberta Director Canadian Taxpayers Federation

Past Pres. Bart Dailley introduced guest speaker John Carpay who is originally from Holland and is, inter alia, the Alberta Director of The Canadian Taxpayers Federation. He is also a member of the Justice Foundation for Freedom of Speech.

John selected Health Care as the subject of his talk today as there has been plenty of discussion on this subject in recent years. Alberta's recent Health Quality report has raised a lot of questions and discussion. The report states doctors have been intimidated and threatened with loss of jobs and licenses when they advocate on behalf of patients. A promised inquiry into this has been shelved and replaced with an examination regarding queue jumping. There is no arbitration for doctors but all other health care givers are given this help. It is perceived that the Province's support of the Canada Health Act is nominal. In fact 51% of doctors who were asked say they have been intimidated. While queue jumping should be verboten, it has been said the former chief of Alberta

Health, Mr. Duckett, said that some Albertans feel entitled to preference in the queue. The Premier's statement said that political preference and queue jumping would be part of the formal inquiry, while intimidation of doctors would not. The Premier has been accused of breaking promises on this, but claims to have lived up to her words.

Most Canadians (and many others) believe that "Canada has the best health care system in the world". In fact, the World Health Organization has us ranked 30th! Other studies say we spend more per capita but the results don't match the expenditures. Access and wait times are not good. Many other countries have public health systems with good service and virtually no wait times. Government Funding and Government Delivery here seem to be different in health care than in many other government services, and not to the benefit of health care. In many European countries, health care is funded by government but much of the work is provided by private operators very competently and efficiently. Three countries that provide government funding and service for health care while banning private operators are Cuba, North Korea and Canada.

In fact, in Canada, there is some two-tier health care with private clinics providing service for a fee while not billing the province. The Canada Health Act

### **Rotary Literacy Month**

#### Rotary's influence, Dolly's Imagination Library puts books into the hands of children

The wonderful partnership between Dolly Parton and Rotary International continues to flourish in communities both large and small all across the USA, Canada, and the United Kingdom.

Although every community approaches the program in its own way, one thing impresses me much more than dollars raised or even time invested – and this is the enormous influence Rotarians exert in their communities.

On many occasions, we have witnessed how Rotarians use their influence to leverage support from both the public and private sector. Rotarians bring instant credibility to the table and consequently, local, state and provincial governments are eager to join forces with Rotary and Dolly to bring the Imagination Library to their children. Likewise many Rotary clubs have been successful in teaming up with United Way to launch the program in their communities.

Influence is an earned commodity and we are fortunate that the decades of good will and great work of Rotary now benefits the children of the Imagination Library.

Dolly Parton helps Rotarians spread literacy

It can be hard to find books in Canada's vast Yukon. Claire Derome, 2009-10 president of the Rotary Club of Whitehorse-Rendezvous, knows of only one bookstore outside the capital, and in remote areas, access to libraries is also limited. Derome

wanted to launch a literacy project that would reach all Yukon communities, and she found one in Dolly Parton's Imagination Library.

Every month, Imagination Library mails an age-appropriate book to each child in the program, until age five. Research showed that up to 85 percent of families receiving books through the program read to their children every day.

Derome, who has a graduate degree in education, did not need more convincing. "The number of books you have at home is a good indicator of future success in school," she says. Her Rotary club worked with the Yukon government and the Yukon Literacy Coalition to bring Imagination Library there, and 900 children are currently enrolled. The Dollywood Foundation and the participating community split the program costs; in Yukon, the Whitehorse-Rendezvous club covers the \$3.60 per child per month.

Imagination Library does not have income requirements. "Dolly did not want any child to feel singled out or left out," says David Dotson, president of the Dollywood Foundation. Parton was adamant that the books be new, because of her own experiences growing up with hand-me-downs. And in mailing the books to each young person, she wanted to recreate the joy she felt as a child when the Sears catalog arrived at her home, addressed to her family.

Imagination Library serves children in the United States, Canada, and the United Kingdom. In 2001, 2,500 children were participating in the program; today they number almost 700,000. Imagination Library and Rotary International teamed up in 2009, and Rotary clubs are involved in the program in roughly 300 communities.
