## November 26th, 2013

Peter Bickham encouraged us to contribute to TRF and to consider signing up for a monthly contribution to spread the joy of giving throughout the year.

Garth Plunkett thanked all who contributed to the Calgary Rotary Clubs

Foundation. The report of the Foundation on the tables showed that the balance in the Foundation for our Club totaled \$137,497 as of February 28, 2013. This is up from \$119,001 in the previous year. From the earnings, \$4,425 is being distributed to our Club to support our community service work.

Bart Dailley took all of the full shoeboxes that we members brought in to the meeting and will take them up to the Samaritans Purse warehouse. If you haven't filled your box and brought it in by now, you will need to take it to the Samaritans Purse by next Monday.

In another matter regarding the shoeboxes, Garry Miller reminded us that we help pack boxes at the Samaritans Purse warehouse at 20 Hopewell Way NE this Thursday from 4:00 to 6:30 pm, and on Monday December 2nd from noon until 3:30 pm.

Tammy Truman reminded us of the Seniors Christmas lunch at the Carriage House on December 10th. The table hosts are encouraged to wear dark pants or skirt, and a white or light coloured shirt or top.

Tammy showed her generosity by donating tickets to the hockey game, complete with a parking pass for a space near the Saddledome. These were raffled off with Anne Dale the lucky winner. I don't know how much was collected but there were a lot of hands up with a \$5 bill.



David Wartman has chaired the committee of the Club that has been working to obtain charitable status for the Chinook Rotary Club Society. The application was submitted in the spring. Since that time there have been several requests for additional information and clarification followed by responses by our committee. On November 12th, the CRA gave

notification that subject to amending the bylaws of the Society in a manner acceptable to them, the charitable status would be granted.

David moved a Special Resolution:

"WHEREAS, the Chinook Rotary Club Society is desirous of becoming a registered Canadian charity; and WHEREAS, the Canadian Revenue Agency has indicated that such registration will be forthcoming subject to the bylaws of the Society being amended in a manner consistent with the stated charitable aims of the society; and WHEREAS the Canadian Revenue Agency has provided wording for the proposed changes to the bylaws of the Chinook Rotary Club Society; and WHEREAS the mandate of the Society to do charitable works has been expanded to include both domestic and international activities;

THEREFORE BE IT RESOLVED that the bylaws of the Chinook Rotary Club Society be amended as follows:

1. That the current objectives of the Society as identified in Clauses i to v under the heading OBJECTIVE be deleted and replaced with the following wording:
  - i. To receive and maintain a fund or funds and to apply all or part of the principal and income therefrom, from time to time, to qualified donees as defined in subsection 149.1(1) of the Income Tax Act
  - ii. To advance education by providing publicly available scholarships, bursaries and other forms of financial assistance to students for post-secondary education and other educational programs.
  - iii. To relieve poverty in developing nations by providing food and other basic supplies to persons in need.
  - iv. To undertake activities ancillary and incidental in the attainment of the above charitable purposes.
2. That the current Clause 8 "The By-laws may be rescinded, altered or added to by a Special Resolution" become Clause 9 and a new Clause 8 be substituted therefore to read:

### 8 DISSOLUTION

Upon the dissolution of the corporation, and after payment of all debts and liabilities, its remaining property shall be distributed or disposed of to qualified donees described in subsection 149.1(1) of the Income Tax Act.

3. That Clause 2 iii, be amended by deleting the words "Chairperson-World Community Service Committee" and substituting therefore the words 'Director Club Financial'.

The motion to accept these changes to the By-laws was passed by a show of hands of the members present.

The granting of "Charitable Status" to the Society would enable us to issue charitable donation receipt for the donor's income tax purposes.



The members expressed their thanks to David Wartman for his work on this complicated task, and it is hoped that I copied David's words correctly but this is not intended to be the official version on the By-law changes.

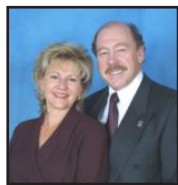

At the end of every Rotary year, contributions directed to the Annual Fund-SHARE from all Rotary clubs in the district are divided between the World Fund and the District Designated Fund (DDF).

At the end of three years, your district can use the DDF to pay for Foundation, club, and district projects that your club and others in the district choose. Districts may use up to half of their DDF to fund district grants. The remaining DDF may be used for global grants or donated to PolioPlus, the Rotary Peace Centers, or another district.

## WORLD FUND

The World Fund provides the necessary funding for our highest priority activities around the globe. While 50% of SHARE-designated contributions are applied to the World Fund, you can also direct your entire gift to the fund. The Foundation uses the money to pay for grant and program opportunities available to all Rotary districts.
