ALBERTA RAT PATROL Phil Merrill, Inspector

Bart Dailley introduced our guest speaker Phil Merrill, inspector with the Alberta Rat Patrol.

Phil has been with the Provincial Government for over forty years as a Problem Wildlife Specialist, and as an Inspector for Regulatory Services. He recently became the Provincial Rat and Pest Specialist in 2012.

Phil reports there are twelve different rat species, and no other rodent is as destructive, and has outwitted man in his efforts to exterminate it.

Rats seldom venture far from their nest, and are nocturnal. Rats are a warm climate rodent, and burrow in ground, or live in a warm building. Rats must have a supply of man's food like



grain, stored food or garbage. They contaminate more than they eat and destroy approximately 20% of the world's stored food.

Rats adapt to their environment. Swimmers can access a building through toilet traps. The climbers access a building by climbing electrical or support wires. Rats destroy property by chewing---their teeth continually grow.

Rats are sexually mature in seven weeks, and a pair can have a litter each month, which can result in 15,000 offspring a year (as the offspring also reproduce).

The Alberta Rat Control Zone was created in 1951 to try to eliminate rats from Alberta, and maintain a rat free province. Alberta's success staying rat free depends upon a network of pest control officers across the province, the support of all citizens to report rat sightings and destroy rats.

Pet rats sold by pet stores are also reported, and must be destroyed.

The costs are substantial---\$3 million each year to control these pests, and \$10 million each year in food contamination and damage.

Alberta continues to be the only rat free zone in North America.

The new Rotary year: Changes you should know about

For three years, 100 districts have been testing Future Vision, a pilot of The Rotary Foundation's new grant system, which was designed to increase Rotary's effectiveness during the next century of service. As the new Rotary year dawns, the future has begun. All districts begin using the simplified grant structure 1 July. There will be three types of grants: global, district, and packaged.

Also on 1 July, new leaders will take office at the club, district, and international levels:

• Ron D. Burton, of the Rotary Club of Norman, Oklahoma, USA, will become Rotary's 103rd president and will encourage Rotarians to Engage Rotary, Change Lives

Anne L. Matthews, a member of the Rotary Club of Columbia East, South Carolina, USA, will become the first woman to serve as vice president

Dong Kurn Lee, of the Rotary Club of Seoul Hangang, Korea, will • take over as Rotary Foundation trustee chair

Other changes for 2013-14:

Rotarians will be allowed to form satellite clubs, whose members meet at a different time and location from their parent clubs

- Districts will be able to form an unlimited number of e-clubs
- The name of Rotary's fifth Avenue of Service will change from "New Generations Service" to "Youth Service"
- The dues Rotary clubs pay Rotary International will increase US\$1 to \$53 per member
- A redesigned Rotary website will be launched in late summer
- The RI Board of Directors will seat nine new directors 1 July, along with 2013-14 President-elect Gary C.K. Huang, of the Rotary Club of Taipei. Taiwan

The Rotary Foundation Board of Trustees will seat five new members including Monty J. Audenart, of the Rotary Club of Red Deer East, Alberta, Canada

July 2nd, 2013
