Bart Dailley introduced Derek Fildebrandt, Alberta Director of the Canadian Taxpayers Federation. He served as the CTF's National Research Director from 2009 to 2012. His work focussed on Freedom of Information, public sector and MP pension reform, and federal program spending and reviews. Before joining the CTF, Derek was a policy analyst for the Form of Labour Market Ministers in Victoria BC. There he worked to liberalize inter-provincial trade and labour mobility.

Derek grew up in small military towns in eastern Ontario. He graduated from Carlton University in 2008, and now lives with his family in Calgary. When not working, Derek is a fisherman, sport shooter and heavy-metal guitarist.

Derek's Presentation:

Derek started his presentation by commenting on the lavish spending of the Redford Government on such projects as the highway billboards with her name, the "Sky Palace" which was to be her residence, and the use of government planes for private and political purposes. Derek went on to talk of the folly of running three separate budgets — a capital budget, an operations budget and a reserve budget.



Derek noted that the current provincial debt is over \$11.3 billion. He suggested the current rate of spending will lead to a debt of over \$20 billion by the next provincial election in 2016.

Derek said there needs to be legislation to require balanced budgets. There should be no raises for members of the legislature, deputy ministers and top level bureaucrats if budget targets are not met.

Derek answered questions from those present for about 20 minutes. He is in favour of recall of elected officials, but is not in favour of term limits.

President Stephen thanked Derek for his informative presentation.
