Two of our relatively new members Bill Stemp and Bob Gentles presented Classification Talks to the Club.

#### Bill Stemp

Born in Edmonton, he and Maria have five children and five grandchildren. After trying out university courses in engineering and medicine, he settled on law. His company, Stemp & Company, specializes in being Patent and Trademark Agents but also provide services in the area of wills, estates, real estate, mortgages, litigation, and corporate commercial transactions. If you have need for help from a lawyer, Bill would be the man to contact.



Most patents are granted for changes to existing ideas rather than for completely new novel ideas. Trademarks should be assigned to the individual and licensed to the corporation, so that they remain separate from the corporation in a case of the failure of the corporation, the Trade Mark would not be involved in the liquidation. He gave the example of Bernard Callebaut having been owned by the corporation, and the individual losing the right to use his own name in future businesses when the original corporation failed.

Bill became a member of our Club in 2012 with the Classification of Legal/Lawyer.

#### Bob Gentles

Born in Blairmore and his family lived in Moose Jaw for some time. He has a MBA.

Bob enjoyed his four years teaching economics at SAIT and related a story about Asian students striving for even one additional mark on an exam because they received rewards back home for marks attained in their courses. He discovered that if they obtained a mark of 85%, the loan given to them by their employer would be converted into a grant. That is a nice incentive to do well.

Bob now works with The Calgary SCOPE Society, which has a budget of \$17 Million, mostly funded by the provincial government.



Checking on the web site [www.calgaryscope.org](http://www.calgaryscope.org) you will find that it is a non-profit agency working in alliance with people with development disabilities, their families and friends and other community members. Their objective is to understand problems and create solutions to personal and social justice issues. The staff at SCOPE act as advisors, create events, do presentations and much more. They also help with parking at Spruce Meadows.

Neil Beatty from the World Community Services Committee outlined the benefits of matching grants for two of our WCS projects. Details are given elsewhere in this Arch.



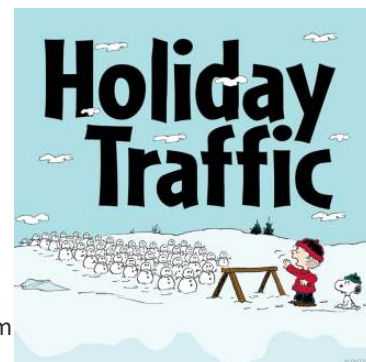

## International Service

The World Community Service Committee is involved with other Rotary Clubs in Calgary supporting an RI Global Grant education project in Cambodia "Child's Future - Education Project".

The project has been able to raise funds locally, as well as being able to leverage these donations at the District 5360 level, and with funds from the Government of Canada through TRF Canada.

Currently the project grant submission is before the Rotary Foundation seeking matching funds of \$116,390 USD. This will require a site visit by TRF representatives. Manon Mitchell (RC Calgary) is there to meet them and ensure they have all the required information.

Our Club's donation is \$5,000, and through all the matching, this will grow to \$28,000USD. This goes toward the total project budget of \$309,172.

This demonstrates the level of leverage made possible through your support of the Rotary Foundation. As you stand out in the parking lot this weekend, remember that the funds you are raising can be leveraged, sometimes **many times over**, to support projects both in our local community and internationally !!
