### **US Consulate** Matt Whitton, US Consular Section Chief



Our guest speaker, Matt Whitton was introduced by Bart Dailley. Matt is the US Consular Section Chief of the US Consulate here in Calgary. In Matt's 2 ½ years in Calgary he has never met better partners and friends compared to any of his other foreign assignments. He is one of 10 US employees occupying 6 consulates across Canada. The remainder of the support staff are Canadian . His namesake and great grandfather lived in Ingersol ON when he enlisted for the 1st World War.

Matt pointed out that although our two countries may run into issues such as USMCA trading agreements, we have a history of co-operation second to none in the world. Our collaboration in space exploration, our military's co-operation, arctic health and science, search and rescue, as well as participation in the James Web Telescope that will be completed in 2021, is just a small sampling of co-operation by our two countries over the years. Present issues that are being addressed together, such as security against cyberattacks, the opioid crises, law enforcement along with security along our borders, all help to ensure healthy travel and trade between Canada and the US. Our collaborative efforts to address natural disasters is evident in battling forest fires which know no borders.



Rotary has always been a valuable partner in US and Canadian relations. Our hands across the border weekend in Waterton and Glacier National Park is one of many

Rotary sponsored friendship weekends that take place between our countries.

The labour force of both nations is very transient across the border thanks to our special relationship. Immigration laws of 1952 still apply in limiting Canadian stays in the US to 180 days per year in an attempt to prevent unlawful residency. He noted that NAFTA is still the trade agreement in effect until USMCA is ratified.

We are excited to share some recent updates to Rotaract.

#### Council on Legislation: Elevate Rotaract

The 2019 Council on Legislation passed enactment 19-72 to acknowledge Rotaract Clubs in the RI Constitution and Bylaws, and elevate them as an important member of the Rotary family. Rotaract Clubs will continue to have their own standard constitution but will have greater support from RI. Our organization will benefit from this change because it broadens the definition of membership in RI to include Rotaract Clubs. We will be able to learn more about Rotaractors and improve the support and resources we offer to help Rotaract grow. As Rotaractors become our partners in service, we'll also be able to better track their impact as well as amplify our reach in communities around the world.

#### **Recent Board Decisions**

The RI Board of Directors made two important decisions to provide greater leadership opportunities for Rotaractors at their April meeting.

Rotaract clubs can co-sponsor Interact clubs!

The Rotary Code of Policies was amended to allow a Rotaract Club to co-sponsor an Interact Club with one or more Rotary Club sponsors. Rotaract Clubs will be encouraged to co-sponsor Interact Clubs to build relationships with Interactors, encourage
