## TAZA Development

Dan Van Leeuwen

Bart gave a short intro for the speaker as he didn't know who was coming from the TAZA group.

Mr. Van Leeuwen is the Managing Director for the project on the Tsuut'ina Nation land adjacent to the Ring Road. The project is a 50-50 partnership between the nation and Canderel, with the latter putting up the total funds for the \$4.5 billion development, and the Nation putting up the land which would be used. Details are sketchy at this time but would involve three locations along the route.

The following has been extracted from a July 11th, 2016 press release:

- Tsuut'ina Park

About 500 acres in size and located south of Glenmore Trail, between 37th Street and west of Sarcee Trail. This development will focus on entertainment and hospitality, while complementary the Grey Eagles Resort and Casino, as well as creating high-value retail.

- Tsuut'ina Crossing

360 acres east of the Ring Road and west of Oakridge community. This development will have a major innovation and research campus, as well as a integrated health and wellness centre, all in a park like setting.



- Tsuut'ina Centre  
380 acres located south of Bullhead Road and north of Fish Creek Park. Integrated with the administrative and community services of the Nation will be several parcels used to support retail and commercial activities.

President George thanked Mr. Van Leeuwen with a Polio Plus Contribution Certificate.

Map showing Taza development proposed by Tsuut'ina First Nation and proximity to Lakeview and 37th Street S.W.

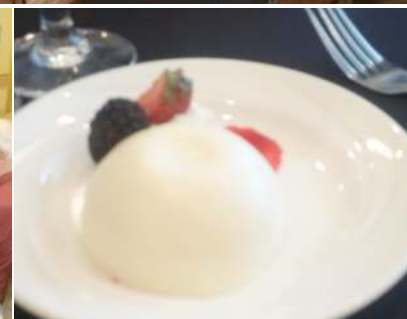

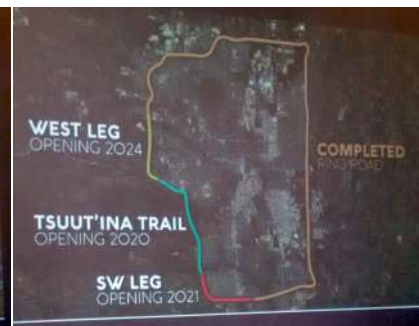

## If you were wondering why it is so important to finish the job ...

WHO Papua New Guinea, 21 July 2018 at 22:24

WHO's International Travel and Health recommends that all travellers to polio-affected areas be fully vaccinated against polio. Residents (and visitors for more than four weeks) from infected areas should receive an additional dose of bivalent oral poliovirus (bOPV) or inactivated polio vaccine (IPV) between four weeks and 12 months prior to international travel. International travellers undertaking urgent travel should receive a dose of polio vaccine at least by the time of departure. Travellers should be provided with a written record of such vaccination, preferably using the International Certificate of Vaccination or Prophylaxis. Some polio-free countries may require travellers resident in polio affected countries to be immunized against polio in order to obtain an entry visa.

### ADVICE ON POLIO VACCINATION

### FOR TRAVELLERS TO/FROM PAPUA NEW GUINEA

There is currently an outbreak of poliovirus in Papua New Guinea.

#### For those travelling out of Papua New Guinea

- ♦ If you are a resident or long-term visitor (stays of >4 weeks in any part of Papua New Guinea), **get a dose of polio vaccine** before leaving the country.
- ♦ Get an **International Certificate of Vaccination** (yellow booklet) to record and serve as proof of your polio vaccination.

#### When to get the vaccine

- ♦ Ideally, you should **get vaccinated between 4 weeks and 12 months** before leaving Papua New Guinea.
- ♦ If you have not had a documented dose of polio vaccine within the past 12 months and need to travel last minute, **get 1 dose of polio vaccine prior to departure.**

#### For those travelling to Papua New Guinea

- ♦ Check with your national health authority on **polio vaccination requirements and schedules.**
- ♦ If you are an adult who previously received 3 or more doses of polio vaccine, you should **get another one-time booster dose.**
- ♦ If you previously only had inactivated polio vaccine (IPV, injectable vaccine), **your booster dose should be oral polio vaccine (OPV),** if available and feasible.
