Think for Actions Committee Dr. Mukarran Zaidi, Chairman



Dr. Mukarran Zaidi spent his earliest years in Kitchener / Waterloo Ontario where he completed his Grade 1. His family then returned to their original homeland and Dr. Zaidi continued his formal education in Karachi. Upon later returning to Canada, he

pursued further education at , Laurentian University, University of Ottawa and the University of Toronto. During this time he

worked as a security guard and did comedy acting. Graduating from the University of Toronto allowed him to follow in his family footsteps as Doctors and Engineers. He credits his privileged up-bringing to allowing him to achieve his education goals leading to his present social status. Dr. Zaidi is a professor at the University of Calgary, as well as operating a clinic in Signal Hill.



It was this privileged background that inspired Dr. Zaidi to become a founding member of Think For Actions. This is a Calgary-based not for profit think tank aimed at empowering and encouraging youth, and helping to

develop their leadership skills. He credits his parents for pushing him to advance his education, a push that less advantaged youth do not always get. Think For Actions seeks to provide this push through youth mentorship.

Think for Actions is a National Think Tank focussed on Muslim affairs, with a focus on community research and professional development of youth. The aim is to engage the government and public at local and national levels to offer new and effective solutions. Dr. Zaidi focussed his attention on improving education in the Muslim community, and is active in dispelling misunderstandings that exist between Muslim and Canadian communities.

The vision is to strengthen youth by providing mentorship opportunities from professionals in the community, and in the longer term develop a research institute. The group arranges workshops for youth where they can meet with professionals and receive career guidance by pairing highschool and university students with professionals in different fields.

Nominate a Deserving Club Member for the Distinguished Rotarian of the Year Award

In Rotary year 2011-12, our Club initiated this annual award to honour one club member who personifies "Service Above Self" both inside and outside of Rotary, at a level above that exhibited by most Rotarians. The award recognizes a member's overall contribution to service during his or her entire time in our Rotary Club, and not just the contribution of the current year. A member must have accumulated at least ten years of service with Chinook Rotary to be eligible to win this award. Jim Thompson, Ron May, Ian Burgess, Bob Montgomery, Joe Hooper, Ron Smith (posthumoulsy) and Hank Popoff have each been bestowed with this honour in past years.. An Awards Committee evaluates all the nominations that it receives, and recommends its choice to the Board of Directors for approval. Past recipients are not eligible to receive the award a second time. The current Awards Committee is comprised of Ron May, Bob Montgomery, Pat Hutchinson, Jim Thompson and Hank Popoff.

Nominations for this award should be made in writing (email acceptable) and directed to Hank Popoff, the Chair of the Awards Committee, to be received no later than <u>May 14, 2019</u>. Any club member in good standing may make a nomination. To avoid embarrassment, it is important to keep the nomination confidential as the Awards Committee may not recommend your nominee. The Awards Committee will separately nominate its own candidate before ranking all the nominations, including its own, utilizing the preset criteria detailed below. Y<u>ou do not have to complete the selection criteria form when submitting a nomination; the Awards Committee</u> will do this.

A nameplate engraved with the name of the person selected for this honour will be added to the trophy which is prominently displayed beside the lectern at our weekly meetings. Additionally, the award recipient will be presented with an attractive recognition piece suitable for display in his or her home or office. The award will be presented at one of our meetings or gatherings when a number of Rotary partners are in attendance.

1.5 km north of Okotoks on an 8-acre parcel of land, in the midst of neighbouring golden canola fields, and nestled among forested landscapes with mountain views.

Our specially trained, professional staff and volunteers provide around-the-clock end-of-life and bereavement care. Attention is paid to physical needs, expert pain and symptom management, and emotional and spiritual well-being as patients prepare for the completion of their life's journey.

The focus of our care is on quality of life and we welcome patient and family input into all aspects of our program.

Unlike the sobering atmosphere of a hospital, the Foothills Country Hospice emanates sweet solitude and soulful comfort, welcoming terminally ill patients and their families into the warm embrace of hospice care.
