Our speaker on September 3rd was Stephanie Doll, Executive Director of Leighton Art Centre (LAC). She has a degree in Archeology and Museum Studies from U of C. She spent 6 years as Director of Exhibitions, Museum and Programming at LAC, where she curated (collected, selected, presented) over 60 contemporary and historical art exhibitions.

She gave us the history of LAC and its founder A.C. Leighton and his wife Barbara. There are over 3000 pieces of art and artifacts.

In 2018, there were 20,000 visitors; 400 at risk and/or low income students for art and nature programs; and the Centre exhibited over 300 local artists in 10 exhibitions.

Bart gave the introduction of Roger Kingcade, his youngest son who has addressed our club on previous occasions, once as a talk show host, and once giving us the history of bourbon whiskey. Roger spent several years in rock radio in Calgary

Next month in London he will be the keynote speaker at the Canadian Society of Club Managers Annual Conference.

The Rotary Foundation (TRF) wrote a letter to President Paul reminding that November is TRF month and asking for member donations. Anthony and his team will be working on that soon.





Ron May introduced guests Scott Cuban and our speaker Roger Kingkade.

In the 60's Sears was the prime US retailer based on their quality of product, guarantee, fair treatment of customers and competitive pricing. In 1978 they published a "yellow book" but a consultant (another bad one) said they were spending too much money on advertising. They cut back and fell to #3, passed by Walmart and Kmart. Roger did not

have much more time to tell us about the final details of Sears demise. He still believes there is room for brick and mortar stores. Amazon must believe it as well because they recently opened a building where clients can shop. Roger answered a number of questions in detail.

The Project goal:

- install a solar system to produce own power
- significantly reduce annual operating expenses
- use savings to purchase supplies of clothing, food, medicines, and educational services.

Annual savings would be Cdn \$ 9,000, from an investment of Cdn \$60,000. One of the partners in the project is U of C's Sustainable Energy Development Program.

She ended her presentation with a request ... "We hope you join us on our next project."

Project Investment

- 65 solar panels, 370 watts/panel
- 99% reduction in Rancho annual electricity costs.

Join us for Cribbage at the Horton Road Legion!!

Thursdays, starting October 10th Game nights commence at 5:30pm for fellowship, nibbles & libations. Games proper start at 6:30pm.

Rules of Engagement as follows: A \$2 entry fee per night/player. Total proceeds to go to the highest point accumulator that evening. All "19" hands will result in a \$.25 fine going to an accumulating pot awarded to any person getting a 24 or greater point hand. After a payout, a new pot is started, and if no award at the end of the evening, the pot gets carried forward. 8 games will be played each evening consisting of 3 matches (3 games for the first two, and 2 games for the third). RI President 2021-22

Shekhar Mehta of India selected to be **2021-22 Rotary International President**



Shekhar Mehta, of the Rotary Club of Calcutta-Mahanagar, West Bengal, India, is the selection of the Nominating Committee for President of Rotary International for 2021-22. He will be declared the President-Nominee on 1 October if no challenging candidates have been suggested.

Mehta acknowledges that current membership trends are a challenge and says that membership development


should be Rotary's highest priority. He believes that focussing on regional plans, successfully transitioning Rotaractors into Rotary clubs, and increasing diversity and female members could yield a 5 percent net growth in membership each year.

"A major brainstorming is needed to find effective solutions suited to different areas of the world," says Mehta. He adds that regional ethos and culture have to be taken into account to find localized solutions, as "one size does not fit all". He believes Rotary can extend to new geographical areas and countries.
