


**Calgary Food Bank Sheryl Barlage, Chief Development Officer** 



**Bob Montgomery introduced** our guest speaker, Sheryl Barlage, Chief Development Officer of the Calgary Food Bank. She has 30 years of experience in fund development and positions in both the nonprofit and private sectors. She is adept in her

leadership, strategy, fundraising, communications, events and stewardship. As part of expanding her appreciation for donors and philanthropy in the corporate sector, Cheryl was fortunate to hold roles in community investment, marketing, communications, government relations and aboriginal affairs at three major energy companies





Cheryl began her presentation by thanking Rotary for inviting her today. Her intent is to share where the food bank has been, and where it's going. At the Calgary Food Bank they have just begun a new distribution model which includes having a volunteer meet you at your vehicle and review your needs, including amounts and types of food you would prefer, and then the volunteer goes back into the food bank and immediately arranges to have a hamper prepared to your specifications (as much as possible).

The Calgary Food Bank is the main charitable hub providing food for all Calgarians in need of assistance. Cheryl noted that there are other smaller food banks in the city which also help to meet these needs.

Their operation does not receive financial assistance from any level of government and therefore depends on donations and many volunteers to make it work. Volunteers make up 62% of their workforce.

Cheryl advised that last year they distributed food hampers at a pace of approximately 750 hampers per day. Their plan for this year is to increase this level to 900 hampers per day. She realizes that this is a significant goal but it is important as our community continues to grow. She noted also that they continue to support major community food suppliers like Mustard Seed and other community food services. She told us about two unique programs by which cont'd on page 4 ...

## **Meeting Minutes**

President Elect Wayne called our meeting to order at 12:15, welcoming all in attendance.

#### **Indigenous Fact**

The Jay Treaty was signed in 1794 between Great Britain and the United States. It provided that American Indians may travel freely across the international boundary into what is today Canada. Under the treaty and corresponding legislation, native

Indians born in Canada, were entitled to freely enter the United States for the purpose of employment, study, retirement, investing, and or immigration. In order to qualify for these privileges, eligible persons had to provide evidence of their Indigenous background at their point of entry.

We had 30 participants at our meeting today which included 4 **Guests**, our speaker Sheryl Barlage, Rotarian Pat Neuman from the Rotary Club of Calgary Stampede, and Rotarian Suzanne Raderkovic from the Rotary Club of Burlington with her guest Roger Kelley. Our guests were introduced by Joe Hooper and welcomed with our 'Welcome to Rotary' song.



Wayne **thanked** Paul for being our scribe today. He also thanked Joe and Jim Hennessy for being our greeters today and for making everyone feel welcome. He thanked Stephen and Anne for all they do for our Club, most notably the regular production of our e-Arch. In addition, we also wish to thank both Neil and Hank for operating our payment system.

#### **Rotary Convention Update**

Wayne noted that Bev is our Club Champion for the next Rotary International Convention (June 21st to 24th, 2025 in Calgary). He then asked Pat Neuman to share an update regarding "hosting the world for dinner". She reminded us that it was Calgary that started the idea of home dinners in 1996 when we hosted our initial Rotary International Convention, and it was so popular that it has become a very well accepted part of Convention hospitality.

At the present time the organizers are seeking groups in the local area to host dinners at a variety of places including their own homes or restaurants or anywhere else that might work. If any of these groups decide to host over 50 convention goers, then arrangements can be made to have them delivered by bus. As a example of a dinner arrangement, Pat told us about one which has already been planned which



includes the Tonkinsons, the Popoffs, and Rob Wolfson, who will be hosting a group of registrants for dinner at the Tonkinson residence. Anyone who would like to arrange a 'home dinner' should go on to the convention website and enter your plans to do so (ask Bev if you need help). Pat also highlighted that everyone who registers for the convention and therefore has a convention pass, will be provided with completely free bus and LRT fares in Calgary throughout the convention. On a general note, Pat told us that there have been 11,000 registrants who have paid to date and that they are anticipating reaching the

30,000 level.

Last year our Club donated over \$6,000 to the Annual Fund of the Foundation, and another \$1,500 to Polio Plus. John noted that it would be wonderful if we could meet this level of giving during the current year or if at all possible increase it. We ask that all our members consider supporting the Foundation (including Polio Plus).

they provide food to students on the weekend, and mobile hampers for the homeless. They also distribute food to newly arrived Calgarians who are moving into new housing.

She explained that the Calgary Food Bank receives approximately 90% of their food from major food retailers (such as Co-op, Safeway, Loblaws and others), which are active in the Calgary market. This food is often close to the "best before" date so fast and efficient food handling is imperative. They are very good at picking up and distributing these food resources quickly.

Sheryl explained that they maintain close communications with their clients and are pleased to report that by providing a significant portion of their necessary food requirements, their clients realize major improvements to many facets of their lives. They report mental improvement as well as prevention of homelessness.

We note that their website at www.calgaryfoodbank.com provides a great deal of information for anyone seeking additional details.

Hank thanked Sheryl for her presentation and advised her that a donation would be made to Rotary's Polio Plus Campaign in appreciation of her joining us today.
