### **Homes for Hope & Polio Update Dan & Marlene Doherty**

Bev welcomed Marlene and Dan Doherty to the podium to tell us about "Homes for Hope". Marlene began by telling us about the program. It is all about local volunteers (including Rotarians with their family and friends) travelling to Northern Mexico to assist in building homes for local families in need.





The general program requires volunteers to get themselves to San Diego at a specific date and time (usually a Thursday pm), where they meet up with the other people in their group. They are then bussed across the border to their project base of operations (a 45 minute trip), and broken down into teams depending on the number of homes they are planning to build. Each team is tasked with constructing a home. Tools are provided on site, and of course professional project leaders provide proper guidance to ensure everything is done correctly and safely. The homes are constructed in two days (Friday and Saturday), and the volunteers return to their own homes on Sunday. The program also provides the family receiving the home with some cash so they can start off with some furniture, clothing and food.

Dan then took over to tell us more about the actual people who receive these newly built homes. He told us about a family with a baby who had medical issues, and was in need of surgery. Through the magic of Rotary, sufficient funds were raised to complete the necessary surgery, resulting with the family not only receiving a new home but also an improved life. He then told us about Anna, a young teenager whose father was blind with cataracts, and whose mother worked cleaning rooms at a local motel. The family lived in an old school bus and was selected to be a recipient of one of the new homes. Rotary not only built them a new home, but also provided \$1,000 for the father's eye operation which restored his sight, and another \$500 to fund Anna's school year. This was another great example of providing "a new life" for this family.



The team has been visiting this area for many years, and has the opportunity to see the families again and to follow their progress. It has proven to be a very emotional and rewarding process for all involved.

Dan told us that they are planning another home building trip next March, and they are seeking more Clubs to gather a team (or to partner with other Clubs to do so) of 15 volunteers to join their crew. Apparently the cost is \$10,000 to fund the building cont'd on page 4 ..



### **You May Want to Know!**

At this time, in1976, a group of member candidates had been sponsored and promoted to form a new Rotary Club, sponsored by the two longest serving clubs in Calgary — Downtown and South — and promoted by an experienced group of their members dedicated to the expansion of Rotary in the district. We were chartered a few months later, on March 1977 and celebrated in April of 1977 at a gathering of Rotary members at the Palliser Hotel. One charter member, Fred Allen, was the son of the presiding District Governor, as we were recognized.

The RI district 536 at that time was all of Alberta, the SE corner of Saskatchewan and the NE corner of BC, with about 40 clubs in the district overall. Our assigned boundary area, which they did in those days, ran from the Stampeder Hotel to South Centre Shopping centre. The major focus was on the Chinook Shopping Centre area and the businesses there as prospective members, as we expanded. We, like all Rotary clubs worldwide at the time, were an all male membership.

One of our Charter Members, the late Ron Smith, had also been a Charter Member of the Calgary West Club. Another Charter Member, John Zaorzirny, left the club soon after we formed to become the Minister of Energy for the Provincial Government. Curly Galbraith, one of the three "wise men" and an RI Vice President, took it upon himself to call every active member on their birthday to offer his personal congratulations. Dr. David Chevalier DC was the first member to pass away. He did so by drowning on a holiday in Mexico. I was contacted by a friend of his years later, who advised he had actually been murdered! Authorities had dismissed that, there was nothing we could do to further follow up.

We have had dozens of fun fund raisers, fellowship and club projects over the years. A few highlights would include:

- Acquiring 1,000 shares of the Stampeder CFL football club during the SAVE OUR STAMPS effort in the mid 80s, when there was a concern about the franchise moving from Calgary. In 1990 we had an outstanding project /fund raiser, the purchase of a chuckwagon in the Stampede to be known as the ROTARIANS. The sponsor canvas was bought for \$20,000, funds raised from all Rotarians in and around Calgary, and there was a big party at Spruce Meadows for participants. Our driver was Stan Robertson. The Kelly Sutherland rig went for \$50,000, sponsored by Petro Canada, and won the race.
- Our Pro Am golf tournament of 1997, not as successful as we hoped for as a fund raiser. The golf pros did well, the tournament was a sell-out but we did better with a member/guest format in later years. Club member Herb Assman, Byers Transport, sponsored a huge trophy for the Pro Am ... we need to re-purpose this trophy, as it was only presented once.

Charter President Greg MacLellen, often is quoted for profound statements. One that seems important as we recover from the nightmare COVID disruption is as follows, "the RI Constitution, Bylaws and Avenues of Service are beautiful ONLY when real people give them hands and feet".

I miss the weekly commitment to meet as a club. I miss the printed roster of members, as the best and handiest link, which for some reason after 40+years, was discontinued. Time to focus on the original Objectives of Rotary ??

supplies, plus \$450 per volunteer to cover other costs. It is a great team building exercise, and provides wonderful fellowship and even better service to the people and community in Mexico.

Marlene took over to give us a brief update on Rotary's fight to eradicate polio. The phrase "polio is only a plane ride away" has been proven true with recent cases showing up in New York City and Britain. Apparently both cases have been traced back to visitors from Pakistan. Marlene confirms that the fight continues with Rotary announcing another \$150 million to fund our vaccine efforts, comprised of \$50 million from Rotary and \$100 million from the Gates Foundation.

Dale thanked our speakers and presented them with our regular certificate in appreciation for their participation.
