The Power of Perception

Alvin Law



Rob Wolfson introduced our speaker today, Alvin law, who is a motivational speaker, a member of the Professional Speakers Hall of Fame and an honorary Rotarian of the Rotary Club of Calgary East and the holder of a Paul Harris Fellowship.

Born with no arms as a result of the drug Thalidomide, Alvin Law challenges his audience members to examine their

current perceptions of themselves, other people, and the world around them so they can overcome the same obstacles he was faced with — not how to live and function with no arms, but how to be a successful, compassionate, positive and engaged human being that leaves the world a better place than how they found it.



He began his presentation by noting that he was excited to be presenting his first gig of 2024. He went on to say that he had been previously scheduled on this date to be in Singapore making a presentation to a large group in that city. Unfortunately this event was cancelled at the last minute, which presented the opportunity to be with us today. He told us about an opportunity he had this past year to make a presentation to the Million Dollar Round Table in Nashville, Tennessee. This group was comprised of 6,500 successful insurance executives, and his 25 minute presentation was well received.



His presentation today is about the power of perception. He went on to provide three different impressions to our group today by initially wearing an expensive suit jacket, then taking off the jacket and presenting with a not tucked in shirt, and finally the perception he made when using his feet to drink from a mug of water, hold a brush to groom his scalp, or to hold a pair of drumsticks with his toes and successfully use them to play an actual drum performance. Three different impressions within

five minutes, all accurate. His point is that the initial impression, while often considered quite important, is not as important as the overall lasting impression.

He went on to tell us about being born on July 22, 1960 and how it happened that he was adopted by a local family who already had two sons, and cont'd on page 3 ...

were prepared to raise Alvin as part of their family. He looks back on this situation today and realizes that it was the very best thing that could have happened. His birth parents were almost homeless, in their 50s, and basically were not capable of raising him. He was adopted and raised by Jack and Hilda Law, who taught him how to use his feet as hands



and, in doing so, gave him the gift of freedom. He uses his story to challenge audiences to rewrite the negative stories they tell themselves, and inspire them to practice cultivating a more proactive and effective outlook on their lives — stop making excuses and start making choices. Law knows, and demonstrates, that attitude is not only about "thinking positive", but instead how we look at and interpret life overall. It is a skill that can be learned and must be practiced.



Law's mix of storytelling, musical performance, and down to earth humor, connect with his audience at an intimate, intense, and individual level. Over 7,500 organizations on five continents have used him to ignite, engage, and transform their people. In addition to being a professional speaker, Law is a trained broadcaster, fundraiser,



award-winning musician, and the best selling author of "Alvin's Laws of Life: Five Steps to Successfully Overcome Anything". He has earned the designation of Certified Speaking Professional, an honour shared by less than 10% of professional speakers worldwide.
